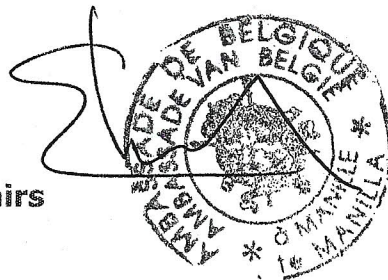
The Embassy informs the Ministry of Foreign Affairs that on the 6th day of October 2015 has been received the denunciation of the Republic of the Sudan.

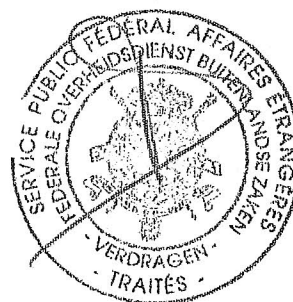

On the 6th day of October 2015, the notification of denunciation of the Republic of the Sudan relating to the above-mentioned international Acts has been deposited with the Federal Public Service Foreign Affairs, Foreign Trade and Development Co-operation of Belgium.

In accordance with the provisions of Article 15 of the Convention, the denunciation shall take effect in respect of the Republic of the Sudan on the **1st day of April 2017.**
