MODUS OPERANDI

Type(s) of offence:	Illegal imports of Saussurea costus roots under mis-declaration, a species enlisted under Appendix-I of CITES and Schedule- VI of the Wildlife (Protection) Act, 1972.
Date of the offence	09/03/2017, 21/04/2017 & 02/06/2017
Place of offence:	Jawaharlal Nehru Port Trust, Nhava Sheva, Maharashtra, India
Country of offence:	China and India
Circumstances of offence:	Customs referred sample of plant roots to the Wildlife Crime Control Bureau of India (WCCB) for examination. From the perusal of documents, it was found that in the description of import material, the plant roots have been declared as Puskarmoola (Inula L). However on physical examination of the sample the roots it appeared to be that of Saussurea costus. Due to the inconsistencies, the decision was taken to examine the consignments at the Port. On examination, the plant roots were found to be the roots of Saussurea costus and not Puskarmoola (Inula L) as declared in documents of import.

Description of modus operandi: Object/ device/concealment method/procedure:

All the three import consignments of Saussurea costus roots were being imported under mis-declaration of the Inula racemosa roots. The plant roots of Inula racemosa morphologically resemble with the roots of Saussurea costus roots to some extent. The Ports of Loading of the consignments was Shanghai and Xingang (China) under the BL No.YMLUS231183063, A567A06388 & OOLU2586938360 and were imported to Jawaharlal Nehru Port Trust, Maharashtra, India. The exporter was Zhejian Medicines and Health Products Import & Export Co. Ltd, ZMC Building, 101-2.N, Zhongshan road, Hangzhou, 310003, China.





Additional information:

Saussurea costus has been categorized as a Critically Endangered plant species by the IUCN and endemic to small patches of the Himalayan mountain ranges in wild e.g Pakistan, China and India. Roots of this plant are widely used in the Traditional Medicines such as in Ayurvedic Formulation, Traditional Chinese Medicines and Tibetan Medicines. The oil extracted from this plant is also used in preparation of Incense, Perfumery compounds etc. and the roots of this plant are used locally, nationally and internationally. By virtue of unregulated collection and over-exploitation and rampant illegal trade, this plant species has been placed internationally under CITES (Convention on International Trade in Endangered Species of Wild Fauna & Flora) and also protected by law within the Union territory of the Government of India through the Wildlife (Protection) Act, 1972. Trade, export, import, cultivation, possession, picking, uprooting of this plant and parts or products are controlled nationally by the Wildlife (Protection) Act, 1972 and also is a punishable offence.

The species is listed under the Schedule-VI of the Indian Wildlife (Protection) Act 1972 and Appendix I of CITES.
