In connection with the above subject matter, notwithstanding that the decision therein has not attained finality and consistent with the precautionary principle embodied therein and in the National Biosafety Framework, you are hereby advised to refrain from acting on any new application for a permit to import for contained use. Likewise, you shall not issue any new biosafety permit for field testing, propagation and for direct use. Furthermore, you shall continue to monitor regulated products that are already in the market and covered by existing biosafety permits which shall not be covered by the above prohibition. Finally, you shall continue to exercise such jurisdiction and other powers conferred under Presidential 1433 and other existing laws.
