Said Certification is **not** applicable to other private exporters/importers who are requesting for Transport Permit for their own respective shipments from NFA.

With reference to the above subject matter, the National Food Authority (NFA) wants to clarify that the said MOA is only by and between the NFA and the International Rice Research Institute (IRRI) which provides among others, a one-year single certificate to IRRI to replace the need for a Transport Permit for every shipment of rice seed varieties that will be used for experimental and research purpose only. Hence, the said Certification is not applicable to other private exporters who are requesting for Transport (Export) permit for their own respective shipments from this office.

This letter was prepared in response to queries of some private exporters/importers seeking clarification on the commodity coverage of the BOC issued Customs Memorandum Circular No. 16-2016.

# **MEMORANDUM OF AGREEMENT**

KNOW ALL MEN BY THESE PRESENTS:

This Agreement made and entered into this 14<sup>th</sup> day of December 2015 at Quezon City, Philippines, by and between:

The NATIONAL FOOD AUTHORITY (NFA), an agency of the government created by virtue of Presidential Decree No. 4 as amended, with principal office and place of business at Philippine Sugar Center Bldg., North Ave., Diliman, Quezon City, represented by its Administrator, RENAN B. DALISAY, hereinafter referred to as NFA.;

The INTERNATIONAL RICE RESEARCH INSTITUTE (IRRI), is a non profit, autonomous international organization, with headquarters at the Municipality of Los Baños, Province of Laguna, Republic of the Philippines, and is represented in this Agreement by its Deputy Director General for Communication and Partnerships Dr. V. Bruce J. Tolentino, hereinafter referred to as IRRI.

#### WITNESSETH:

WHEREAS, IRRI is the world's premier research organization dedicated to reducing poverty and hunger through rice science; improving the health and welfare of rice farmers and consumers; and protecting the rice-growing environment for future generations.

WHEREAS, in the performance of its mandate, IRRI brings into the Philippines different rice seed varieties from different countries for study in the Philippines:

WHEREAS, IRRI is being required by concerned government agencies to secure import permit from the National Food Authority for the rice samples brought into the Philippines;

WHEREAS, NFA is a government agency tasked of, among others, assuring the nation with adequate supply of grains and regulating the importation of rice into the Philippines;

**NOW THEREFORE,** for and in consideration of the foregoing and of the conditions hereinafter set forth, the parties hereby agree as follows:

## I. OBLIGATION OF NFA:

1. Upon request, NFA shall issue a single Certificate in order to replace the need for a Transport Permit for every shipment of rice seed varieties and this certification shall be for a period of one (1) year from the issuance thereof.

#### II. OBLIGATIONS OF IRRI:

- 1. IRRI shall submit a letter requesting NFA to issue the above Certificate.
- 2. IRRI shall guarantee that the rice seed varieties are for experimental and research purposes only. Rice seed varieties for experimental and research purposes shall mean that the quantity of rice seed samples shall not exceed five (5) kilos per variety per shipment.
- 3. IRRI shall make available to NFA all records required by NFA in connection with the Certification that pertains to the rice seed varieties that pass through IRRI's Seed Health Unit. At its option, IRRI can provide to NFA the reports submitted to the Bureau of Plant Industry-Plant Quarantine Service ("BPI-PQS") as compliance of IRRI's foregoing reportorial obligation to the NFA. All requests for reports shall be submitted through electronic mail, among others, by IRRI to the NFA not later than thirty (30) days from the time the request was made.

## III. DURATION:

This Agreement shall be effective and shall be binding for a Period of one (1) year from the date of signing unless sooner terminated by one party for violation of the terms and conditions herein stipulated and provided that a prior notice of thirty (30) days is given to the other party. However, if this agreement will not be terminated within the period as stipulated, it is deemed renewed for the succeeding Period.
