Port of Zamboanga

The Bureau of Customs XIth Collection district has recorded a total of 61 importation entries (all informal entries) from May 8-12 2017. The export division on the other hand, has recorded a total of 12 export entries bringing 73 entries in totality.

No Balikbayan boxes and auction entries were also recorded during the week

The port however issued one alert order and warrant of seizure and detention to an unknown claimant.

392 boxes of cigarettes were also seized by elements of this port with an estimated value of P3, 841,800.00 as of this writing..
