This refers to the herein letter dated 18 November 2015 of Mr. Vincent Sauvalere, Head of Tobacco and Counterfeit Goods Unit (B.2) of European Anti-Fraud Office (OLAF) regarding its investigation of smuggling of tobacco products that enters into the European Union.

The OLAF requested the Bureau of Customs Philippines to assist them in the conduct of their administrative investigation of China Tobacco International Europe Company SRL (CTIC) located in the city of Buzau, Romania. Its initial investigation showed that the consignee/receiver of the cigarettes from CTIC are the Bumi Jaya International Corporation, Subic Bay Global International Corporation and Thaitian Cigarettes and Tobacco Corporation.

Relative to this, you are hereby requested to submit to this office a **Monthly Summary Report of all shipments imported, transhipped or exported** from your ports by the above stated companies for April 2016 and the following months thereafter. Please include all relevant documentary requirements of each shipment in your submission.

Please submit your report for the month of April on or before May 2, 2015. For the succeeding reports, please submit on or before the third working day of every succeeding month. If your ports have not received or processed any shipments of the aforementioned companies, kindly indicate it in your report.

Pursuant to the aforementioned Regulation, OLAF is conducting an Investigation related to the China Tobacco International Europe Company SRL (CTIC) located in the city of Bazau, Romania, with reference number OF/2014/1203. Within this investigation, OLAF/B2 is trying to gather all the necessary evidences to ascertain if the declared exports form CTIC really took place. In this respect, I would like to inform you that OLAF/B2 has received different information from Romanian Customs as regards exportations from this company with destination Philippines.

Enclosed to this letter you will find the relevant custom documentation regarding the above-mentioned consignments.

Based on the COMMISSION REGULATION (EEC) No 2454/93 of 2 July 1993 laying down provisions for the implementation of Council Regulation (EEC) No 2913/92 establishing the Community Customs Code, you are kindly requested to assist OLAF/B2 on the following:

- a) to confirm OLAF/B2 that the relevant consignments have indeed arrived at the declared consignees;
- b) to inform on who paid for the storage of the cigarettes and how;

- c) to inform on further movements of the cigarettes in order to establish their real final destination;
- d) to provide OLAF/B2 with a copy of the documents which accompanied the cigarettes at their arrival;
- to check and inform on persons and companies involved in managing these consignments.
