"ESCENT® L PERFORMANCE ENHANCER"

Based on the product label, brochure, certificate of product registration with the Bureau of Animal Industry and safety data sheet, subject article is a mixture of citric acid, orthophosphoric acid, lactic acid, inactivated yeast, yeast extracts and plant extracts in the form of a brown liquid with characteristic odour. Packed in 1 liter and 5 liters plastic bottles, it is added to drinking water of poultry at different doses to inactivate mycotoxins thereby reducing immunosuppression and oxidative stress, promoting production performance and improving response to vaccination.

Heading 38.24 of the 2012 ASEAN Harmonized Tariff Nomenclature (AHTN) covers, among others, chemical products and preparations of the chemical or allied industries (including those consisting of mixtures of natural products), not elsewhere specified or included. The pertinent Harmonized System (HS) Explanatory Notes (ENs) state that the chemical or other preparations of this heading are either mixtures (of which emulsions and dispersions are special forms) or occasionally solutions. The preparations classified here may be either wholly or partly of chemical products (this is generally the case) or wholly of natural constituents.

In view thereof, subject article is classified under 2012 AHTN subheading 3824.90.99, with Most Favoured Nation (MFN) rate of duty of 3% ad valorem.



Heading 85.01 of the 2012 ASEAN Harmonized Tariff Nomenclature (AHTN) covers electric motors and generators (excluding generating sets). The pertinent Harmonized System (HS) Explanatory Notes (ENs) state that the heading includes rotary motors which produce mechanical power in the form of a rotary motion. They are of many types and sizes according to whether they operate on DC or AC, and according to the use or purpose for which they are designed. The motor housing may be adapted to the circumstances in which the motor will operate (e.g., dust proof, drip proof or flame proof motors; non-rigid mountings for belt driven motors, or for motors which will be subject to much vibration).

In view thereof, subject articles are classified under 2012 AHTN subheading 8501.40.11, with a Most Favoured Nation (MFN) rate of duty of 1% ad valorem.

6 REASONS FOR CLASSIFICATION

Heading 85.36 of the 2012 ASEAN Harmonized Tariff Nomenclature (AHTN) covers, among others, electrical apparatus for switching or protecting electrical circuits, or for making connections to or in electrical circuits (for example, switches, relays, fuses, surge suppressors, plugs, sockets, lamp-holders and other connectors, junction boxes), for a voltage not exceeding 1,000 volts. The pertinent Harmonized System (HS) Explanatory Notes (ENs) state that this heading covers electrical apparatus for a voltage not exceeding 1,000 volts generally used for dwellings or industrial equipment. The heading includes, among others, apparatus for switching electrical circuits. These apparatus consist essentially of devices for making or breaking one or more circuits in which they are connected, or for switching from one circuit to another; they may be known as single pole, double pole, triple pole, etc., according to the number of switch circuits incorporated.

In view thereof, subject articles are classified under 2012 AHTN subheading 8536.50.99, with a Most Favoured Nation (MFN) rate of duty of 7% ad valorem.

Based on the technical card submitted, subject article is frozen pork cutting fat containing ≥95% fat. The fat comes from loin and collar and presented as 18 kg naked block and kept below -18°C.

Note 1(c) to Chapter 02 of the 2012 ASEAN Harmonized Tariff Nomenclature (AHTN) excludes animal fat, other than products of heading 02.09 (Chapter 15).

General Explanatory Notes of Chapter 02 states that animal fat presented separately is excluded (Chapter 15) (except in the case of pig fat, free of lean meat, and poultry fat, not rendered or otherwise extracted, which fall in heading 02.09 even if fit only for industrial use), but fat presented in the carcass or adhering to meat is treated as forming part of the meat.

Heading 02.09 of the 2012 ASEAN Harmonized Tariff Nomenclature (AHTN) covers pig fat, free of lean meat, and poultry fat, not rendered or otherwise extracted, fresh, chilled, frozen, salted, in brine, dried or smoked. The pertinent Harmonized System (HS) Explanatory Notes (ENs) state that the pig fat of this heading is restricted to fat free of lean meat; such fat falls in the heading even if suitable only for industrial use. Meat in forms commonly eaten as such is excluded (heading 02.03 or 02.10 as the case may be, for example, streaky pork and similar meats interlarded with a high proportion of fat, and fat with an adhering layer of meat).

Subject article does not have any adhering layer of meat, but only small patches of meat resulting from scraping process.

In view thereof, subject article is classified under 2012 AHTN subheading 0209.10.00, with a Most Favoured Nation (MFN) rate of duty of 5% ad valorem.

Based on the product specification submitted, subject article is frozen minced pork fat containing 95% (±5%) fat. The cutting fat from shoulder, ham, loin, and belly is minced to 3 mm. It is packed in polybock and kept below -18°C.

Note 1(c) to Chapter 02 of the 2012 ASEAN Harmonized Tariff Nomenclature (AHTN) excludes animal fat, other than products of heading 02.09 (Chapter 15).

General Explanatory Notes of Chapter 02 states that animal fat presented separately is excluded (Chapter 15) (except in the case of pig fat, free of lean meat, and poultry fat, not rendered or otherwise extracted, which fall in heading 02.09 even if fit only for industrial use), but fat presented in the carcass or adhering to meat is treated as forming part of the meat.

Heading 02.09 of the 2012 AHTN covers pig fat, free of lean meat, and poultry fat, not rendered or otherwise extracted, fresh, chilled, frozen, salted, in brine, dried or smoked. The pertinent Harmonized System (HS) Explanatory Notes (ENs) state that the pig fat of this heading is restricted to fat free of lean meat; such fat falls in the heading even if suitable only for industrial use. Meat in forms commonly eaten as such is excluded (heading 02.03 or 02.10 as the case may be, for example, streaky pork and similar meats interlarded with a high proportion of fat, and fat with an adhering layer of meat).

In view thereof, subject article is classified under 2012 AHTN subheading 0209.10.00, with a Most Favoured Nation (MFN) rate of duty of 5% ad valorem.



General Explanatory Notes of Chapter 02 states that meat and meat offal remain classified in this Chapter whether or not they have undergone tenderising treatment with proteolytic enzymes (e.g., papain) or have been cut, chopped or minced (ground).

Heading 02.06 of the 2012 ASEAN Harmonized Tariff Nomenclature (AHTN) covers, among others, edible offal of bovine animals, fresh, chilled or frozen. The pertinent Harmonized System (HS) Explanatory Notes (ENs) state that the edible offal of this heading includes, among others, heads and cuts thereof (including ears).

In view thereof, subject article is classified under 2012 AHTN subheading 0206.29.00, with a Most Favoured Nation (MFN) rate of duty of 7% ad valorem.

Heading 85.17 of the 2012 ASEAN Harmonized Tariff Nomenclature (AHTN) covers among others, other apparatus for the transmission or reception of voice, images or other data, including apparatus for communication in a wired or wireless network (such as a local or wide area network), other than transmission or reception apparatus of heading 84.43, 85.25, 85.27 or 85.28. The pertinent Harmonized System (HS) Explanatory Notes (ENs) state that other communication apparatus includes apparatus which allows for the connection to a wired or wireless communication network or the transmission or reception of speech or other sounds, images or other data within such a network. They may be configured, for example, as public switched telephone networks, Local Area Networks (LAN), Metropolitan Area Networks (MAN) and Wide Area Networks (WAN), whether proprietary or open architecture. This group includes, among others, routers, bridges, hubs, repeaters and channel to channel adaptors.

In view thereof, subject article is classified under 2012 AHTN subheading 8517.62.51 with Most Favoured Nation (MFN) rate of duty of zero; and ASEAN Trade in Goods Agreement (ATIGA) and ASEAN-China Free Trade Area (ACFTA) rate of duty of zero, subject to submission of Certificate of Origin (CO) Forms "D" or "E", respectively.

"DOW™ LLDPE DFDC-7087 NT 7"

Based on the technical information and declaration of composition submitted, subject article is an ethylene-butene copolymer, containing, by weight, less than 95% ethylene and more than 5% 1-butene having slip and anti-block additive concentration of 1500 ppm and 6300 ppm, respectively. It is in the form of odourless, white pellets having melt flow index of 1.0 g/10min at 190 °C and density of 0.922 g/cm³. It is used as a raw material for manufacture of blown films.

REASONS FOR CLASSIFICATION 6

Note 4 to Chapter 39 of the 2012 ASEAN Harmonized Tariff Nomenclature (AHTN) states that the expression "copolymers" covers all polymers in which no single monomer unit contributes 95% or more by weight to the total polymer content. For the purposes of this Chapter, except where the context otherwise requires, copolymers (including copolycondensates, co-polyaddition products, block copolymers and graft copolymers) and polymer blends are to be classified in the heading covering polymers of that comonomer unit which predominates by weight over every other single comonomer unit. Furthermore, Note 6(b) to Chapter 39 states that in headings 39.01 to 39.14, the expression 'primary forms' applies to blocks of irregular shape, lumps, powders (including moulding powders), granules, flakes and similar bulk forms.

Heading 39.01 covers polymers of ethylene, in primary forms.

In view thereof, subject article being an ethylene-butene copolymer is classified under 2012 AHTN subheading 3901.90.90, with a Most Favoured Nation (MFN) rate of duty of 3% ad valorem.
