AO-2016-09-005, OTHERWISE KNOWN AS THE "GENERAL GUIDELINES IN THE IMPORTATION OF 805,200 METRIC TONS, WHITE RICE UNDER THE MINIMUM ACCESS VOLUME COUNTRY SPECIFIC QUOTA (MAV-CSQ) AND THE MINIMUM ACCESS VOLUME OMNIBUS ORIGINS (MAV-OMB) FOR THE YEAR 2016 BY THE PRIVATE

**SECTOR" OR "2016 MAV GUIDELINES"** 

Pursuant to the powers granted to the National Food Authority (NFA) under Presidential Decree No. 4, as amended, to establish rules and regulations governing the importation of rice and the power of the Administrator to issue import permits and any extension thereof<sup>1</sup>, this Memorandum Circular is hereby issued for the information and compliance of all interested parties.

Further, in accordance with NFA Council Resolution No. 854-2017-C dated March 28, 2017, the arrival period of all rice imports under the 2016 MAV Program was extended to not later than **JUNE 30, 2017.** 

In view of the foregoing, the NFA shall officially publish these Guidelines in a newspaper of general circulation and on the NFA website (www.nfa.gov.ph) and the same shall be filed and registered with the Office of the National Administrative Register of the University of the Philippines-Law Center, Diliman, Quezon City.
