#### **REFERENCE**:

This is in view of the additional measures deemed necessary to further ensure secure trade activities for importations made under customs bonded warehouse mode.

### **BACKGROUND:**

- 1. It has been observed that containerized cargoes imported through the customs bonded warehouse mode with "red" selectivity have not undergone the mandatory 100% x-ray examination.
- 2. To avoid delay in releasing, the square root rule is instead being practiced.

## **ISSUE:**

There is a growing concern that the square root rule while it facilitates trade, may give smugglers an avenue to conduct illicit trade under warehousing, therefore the Commissioner needs to address this concern by issuing a memorandum requiring the mandatory x-ray examination of all containerized cargoes consigned and bound to bonded warehouses.

#### **GROUP / DIVISION / COLLECTION DISTRICT / COMMITTEE COMMENTS:**

The immediate issuance of this memorandum is necessary to ensure that the customs bonded warehouse shall not be used for smuggling and illegal trade.
