



### 4 DESCRIPTION OF GOOD

### "POSTECH Non-Touch Screen Customer Display, Model PT-DS-1500"

Based on the brochure submitted, subject article is a flat panel display computer monitor with LED (light-emitting diode) backlight. Designed to be connected to a computer via a VGA (Video Graphic Array) port, it measures 430 mm x 390 mm x 175 mm (WxDxH), weighs 3.5 kg, has a screen size of 15 inches, and is rated at 100~240 V AC-12 V DC. Subject article is used as a point of sale display to show customers their transactions.



### 5 REASONS FOR CLASSIFICATION

Heading 85.28 of the ASEAN Harmonized Tariff Nomenclature (AHTN) 2017 covers, among others, monitors and projectors, not incorporating television reception apparatus. The pertinent Harmonized System (HS) Explanatory Notes (EN) state that this heading covers, among others, monitors capable of directly connecting to and designed for use with an automatic data processing machine of heading 84.71. These monitors are distinguishable from other types of monitors and from television receivers. The monitors of this group may be characterized by the following features: (1) They do not incorporate a channel selector or video tuner; (2) They are fitted with connectors characteristic of data processing system (e.g., VGA connectors, among others); (3) The viewable image of these monitors does not generally exceed 76 cm (30 inches); among others.

In view thereof, subject article is classified under AHTN 2017 subheading 8528.52.00A with a Most Favoured Nation (MFN) rate of duty of zero and ASEAN-China Free Trade Area (ACFTA) rate of duty of zero, subject to submission of Certificate of Origin (CO) Form "E".

This ruling shall be valid for five (5) years from the date of issuance and shall continue to apply unless the law, facts, or circumstances supporting this ruling have changed.

### 4 DESCRIPTION OF GOOD

### "TIAZILIN"

Based on the product specification and certificate of formula submitted, subject article is a feed premix antibiotic in the form of pale yellow powder containing tiamulin hydrogen fumarate and corn starch as carrier. It is formulated to prevent and treat bacterial infections and respiratory diseases for swine and poultry. Subject article is packed in 25 kg bags and administered by mixing the powder to the swine or poultry feeds at a rate of 0.2 to 2.0 kg per ton of feeds.

### 5 REASONS FOR CLASSIFICATION

Heading 23.09 of the ASEAN Harmonized Tariff Nomenclature (AHTN) 2017 covers preparations of a kind used in animal feeding. The pertinent Harmonized System (HS) Explanatory Notes (EN) state that the heading includes, among others, preparations for use in making the complete feeds or supplementary feeds. These preparations, known in trade as "premixes", are, generally speaking, compound compositions consisting of a number of substances (sometimes called additives) the nature and proportions of which vary according to the animal production required. These substances include, among others, those which improve digestion and, more generally, ensure that the animal makes good use of the feeds and safeguard its health: vitamins or provitamins, amino-acids, antibiotics, coccidiostats, trace elements, emulsifiers, flavourings and appetisers, etc.

In view thereof, subject article is classified under AHTN 2017 subheading 2309.90.20 with a Most Favoured Nation (MFN) rate of duty of zero and ASEAN Trade in Goods Agreement (ATIGA) rate of duty of zero, subject to submission of Certificate of Origin (CO) Form "D".

This ruling shall be valid for five (5) years from the date of issuance and shall continue to apply unless the law, facts, or circumstances supporting this ruling have changed.

#### 4 DESCRIPTION OF GOOD

### "GYPROC® PROCOTE"

Based on the safety data sheet, product brochure, and process flow diagram submitted, subject article is a gypsum-based undercoat plaster in the form of off-white powder. It is composed of calcium sulphate hemihydrate (gypsum), calcium carbonate, expanded perlite, cellulose ether, and modified starch. Packed in 20 kg polypropylene bags, it is mixed with water to make a plaster mortar and applied to level an uneven wall or ceiling surface. Subject article provides a crack-free finish with adhesive and heat insulation properties.

### 5 REASONS FOR CLASSIFICATION

Heading 32.14 of the ASEAN Harmonized Tariff Nomenclature (AHTN) 2017 covers, among others, non-refractory surfacing preparations for façades, indoor walls, floors, ceilings or the like. The pertinent Harmonized System (HS) Explanatory Notes (EN) state that the products of this heading are preparations of widely differing composition which are essentially characterised by the uses to which they are put. These preparations are usually put up in a more or less pasty form and in general they harden or cure after application. However, some are in solid or powder forms which are made pasty at the time of use by heating (e.g., by melting) or by addition of a liquid (e.g., water). The products of this heading are usually applied with a caulking gun, a spatula, a trowel, a plasterer's float or similar tools. It further state that non-refractory surfacing preparations are used on façades, indoor walls, floors and ceilings, swimming pool walls and floors, etc., to make them waterproof and improve their appearance. Generally they remain visible as the final surfacing. This group includes, among others, powdered preparations consisting of equal parts of plaster and sand with plasticisers.

In view thereof, subject article is classified under AHTN 2017 subheading 3214.90.00, with a Most Favoured Nation (MFN) rate of duty of 5% ad valorem and ASEAN Trade in Goods Agreement (ATIGA) rate of duty of zero, subject to submission of Certificate of Origin (CO) Form "D".

This ruling shall be valid for five (5) years from the date of issuance and shall continue to apply unless the law, facts, or circumstances supporting this ruling have changed.





Based on the brochure and technical information submitted, subject article is a curved plate made from stamping carbon steel plate conforming to JIS (Japan International Standard) SS400/SM490A. Being a component in the fabrication of NS Eco-Pile™, it is installed outside the pipe (at specified depth from the pipe head) and works as a holder to lock the pipe when mounted to the machine adaptor. The pertinent Harmonized System (HS) Explanatory Notes (EN) state that this heading covers all iron or steel articles obtained by forging or punching, by cutting or stamping or by other processes such as folding, assembling, welding, turning, milling or perforating other than articles included in the preceding headings of this Chapter or covered by Note 1 to Section XV or included in Chapter 82 or 83 or more specifically covered elsewhere in the Nomenclature.

Based on the technical brochure and certificate of product registration from the Food and Drug Administration (FDA) submitted, subject article is an antiparkinson medicament in tablet form, containing levodopa and carbidopa (as monohydrate). Packed in white opaque high density polyethylene (HDPE) bottles with polypropylene closure, containing 100 tablets, subject article is indicated for the treatment of Parkinson's disease and syndrome.

# 5 REASONS FOR CLASSIFICATION

Heading 30.04 of the ASEAN Harmonized Tariff Nomenclature (AHTN) 2017 covers medicaments (excluding goods of heading 30.02, 30.05 or 30.06) consisting of mixed or unmixed products for therapeutic or prophylactic uses, put up in measured doses (including those in the form of transdermal administration systems) or in forms or packings for retail sale. The pertinent Harmonized System (HS) Explanatory Notes (EN) state that this heading covers medicaments consisting of mixed or unmixed products, provided they are put up in measured doses or in forms such as tablets, ampoules (for example, re-distilled water, in ampoules of 1.25 to 10 cm³, for use either for the direct treatment of certain diseases, e.g., alcoholism, diabetic coma or as a solvent for the preparation of injectible medicinal solutions), capsules, cachets, drops or pastilles, medicaments in the form of transdermal administration systems, or small quantities of powder, ready for taking as single doses for therapeutic or prophylactic use. The heading applies to such single doses whether in bulk, in packings for retail sale, etc.

In view thereof, subject article is classified under AHTN 2017 subheading 3004.90.89, with a Most Favoured Nation (MFN) rate of duty of zero.

# 4 DESCRIPTION OF GOOD

### "QUADRIDERM™ CREAM"

Based on the product literature and certificate of product registration from the Food and Drug Administration (FDA) submitted, subject article is an anti-inflammatory, antipruritic, antibacterial, and antifungal prescription drug, in cream form, containing betamethasone, gentamicin, tolnaftate, and clioquinol. Subject article is indicated for the relief of the inflammatory manifestations of corticosteroid responsive dermatoses when complicated by secondary infection. It is packed in collapsible aluminium tubes of 5 g (gram), 10 g, and 15 g.

### 5 REASONS FOR CLASSIFICATION

Heading 30.04 of the ASEAN Harmonized Tariff Nomenclature (AHTN) 2017 covers medicaments (excluding goods of heading 30.02, 30.05 or 30.06) consisting of mixed or unmixed products for therapeutic or prophylactic uses, put up in measured doses (including those in the form of transdermal administration systems) or in forms or packings for retail sale. The pertinent Harmonized System (HS) Explanatory Notes (EN) state that this heading covers medicaments consisting of mixed or unmixed products, provided they are, among others, in packings for retail sale for therapeutic or prophylactic use. This refers to products (for example, sodium bicarbonate and tamarind powder) which, because of their packing and, in particular, the presence of appropriate indications (statement of disease or condition for which they are to be used, method of use or application, statement of dose, etc.) are clearly intended for sale directly to users (private persons, hospitals, etc.) without repacking, for the above purposes.

In view thereof, subject article is classified under AHTN 2017 subheading 3004.20.10, with a Most Favoured Nation (MFN) rate of duty of 5% ad valorem.

This ruling shall be valid for five (5) years from the date of issuance and shall continue to apply unless the law, facts, or circumstances supporting this ruling have changed.



Available in 25 kg bags, subject article is added to broiler feeds, at a rate of one (1) kg per tonne of complete feed, to help improve overall feed efficiency.

### 5 REASONS FOR CLASSIFICATION

Heading 23.09 of the ASEAN Harmonized Tariff Nomenclature (AHTN) 2017 covers preparations of a kind used in animal feeding. The pertinent Harmonized System (HS) Explanatory Notes (EN) state that this heading covers, among others, preparations for supplementing (balancing) farm-produced feed (feed supplements). Farm-produced feed is usually rather low in proteins, minerals or vitamins. The preparations devised to compensate for these deficiencies, so as to ensure a well-balanced animal diet, consist of proteins, minerals or vitamins plus additional-energy feeds (carbohydrates) which serve as a carrier for the other ingredients. Although, qualitatively, these preparations have much the same composition as those described in complete feed, they are distinguished by a relatively high content of one particular nutrient.



The preparations devised to compensate for these deficiencies, so as to ensure a well-balanced animal diet, consist of proteins, minerals or vitamins plus additional-energy feeds (carbohydrates) which serve as a carrier for the other ingredients. Although, qualitatively, these preparations have much the same composition as those described in complete feed, they are distinguished by a relatively high content of one particular nutrient.

# "THYMOGAM™ (ANTITHYMOCYTE IMMUNOGLOBULIN (ATG) (EQUINE))"

Based on the product catalog, medical insert, certificate of product registration from the Food and Drug Administration (FDA), photograph of packaging, and sample submitted, subject article is an immunosuppressant drug, i.e., a sterile, antithymocyte globulin in the form of transparent to slightly opalescent colourless to pale yellow aqueous solution for intravenous infusion. 


