

Friday	Free / Wash Day	Free / Wash Day

- 1.1. On Fridays, all employees shall be dressed in appropriate business attire. Jeans/"Maong" pants may be considered appropriate if paired with collared polo/shirt (for male employees, or any appropriate blouse/collared shirt (for female)
- 1.2. The following outfit are inappropriate:
 - Tank Top
 - Sleeveless Blouse
 - Distressed Jeans
 - Micro Mini Skirt
 - Shorts
 - Leggings
 - Slippers
- 2. Further, BOC employees, officials and persons under contract of service shall also wear their official Bureau of Customs Identification Card (BOC ID) PVC type for organic personnel and card type for persons under contract of service duly issued by the Human Resource Management Division (HRMD).






