

### BACKGROUND

- 2. On December 15, 2016, CAO 05-2016 was issued to implement the duty and taxfree importation of Balikbayan Boxes sent to families or relatives by Qualified Filipinos While Abroad (QFWA), as provided in Section 800 (g), Chapter 1, Title VIII and other related provisions of the CMTA.

3. In view of the valid issues raised by the stakeholders, the implementation of CAO 05-2016 and CMO 04-2017 was suspended until March 31, 2018 per Unnumbered Memorandum dated 28 September 2017.

MASTER COP

- 4. The concerned Drafting Team recommended the amendment of the said CAO and CMO after consultations with the stakeholders.
- 5. Further, pursuant to the instructions of the Secretary of Finance, a public consultation was held last March 05, 2018 and all position papers submitted by the stakeholders was duly considered in the present draft CAO.

#### DISCUSSION

- The draft CAO on Amended Rules on Consolidated Shipment of "Balikbayan Boxes" under Section 800 (g) of the CMTA was first presented to the Commissioner during the briefing conducted last January 31, 2018, who in principle approved the draft CAO.
- After the briefing, minor amendments to the draft was made to take into consideration the comments of the DOF in its 1<sup>st</sup> Indorsement dated 22 January 2018.
- 8. The revised CAO was posted in the BOC website for the information of the stakeholders and for them to submit their position paper from the date of posting until twelve (12) midnight of March 05, 2018.
- The comments of the stakeholders made during the Public Consultation and in their respective position paper were taken into consideration in the finalization of the CAO.
- 10. The notable amendments to CAO 05-2016 are as follows:
  - a. The definition of the Balikbayan Box (Section 3.2);
  - b. The amount of Processing Fee (Section 4.9);
  - c. The documentary requirements to be submitted by Qualified Filipinos (Section 5.1.3);
  - d. The x-ray machine requirements by the Deconsolidators (Section 5.2.4 and Section 9.3);
  - e. The Sanctions (Section 6); and

- f. The compliance to Data Privacy Act of 2012 (Section 8).
- 11. The final amendments to the draft CAO was presented to the Commissioner during the briefing conducted last March 15, 2018, who adopted and approved the same.
- 12. The recommendation of the Drafting Team to extend the suspension of the implementation of CAO 05-2016 and CMO 04-2017 until the effectivity of the amended CAO was also approved by the Commissioner.
