BOC Memorandum dated 6 March 2017 re: Rice shipments covered

Dear Sec. Dominguez:

This refers to the BOC Memorandum ("Memorandum") dated 6 March 2017, issued by Bureau of Customs (BOC) Commissioner Nicanor E. Faeldon.¹

Said Memorandum informs all district and sub port collectors that "rice importations coming from countries other than Pakistan and India should be subjected to seizure by the

It referred to the letters from the National Food Authority (NFA) Management dated 28 February 2017² and 2 March 2017³, which incorrectly stated that the "arrival period of rice importations under the Minimum Access Volume (MAV) Program for the year 2016 will only be until 28 February 2017, except for rice importations from Pakistan and India as source countries x x x".

The good Secretary has been well informed by the members of the NFA Council in a past meeting of the amendment of the 2016 MAV Guidelines, which the NFA Council approved on 27 February 2017⁴, effectively extending the arrival period of the rice importation under the 2016 MAV to 31 March 2017. This extension is effective to all rice importation under the 2016 MAV regardless of the source country.

Further, this extension has been made known to both the NFA Administrator and the BOC Commissioner in separate letters. In particular, the NFA Council, through the NFA Chairperson, directed the NFA Administrator to immediately and strictly comply with the NFA Council Resolution while the BOC Commissioner was requested to respect the same.

The NFA Council likewise highlighted to the good Secretary that the qualified and legitimate rice importers under the 2016 MAV are merely awaiting clearance and assurance from the BOC that their rice import allocations will not be subjected to seizure. It is worth noting that the importers who have already commenced shipment of their rice import allocations, rather than sending the shipment back to their suppliers, they have opted to store rice imports in facilities outside the specified point of entries, thereby incurring additional costs such as demurrage fees and other related payments.

A mere technicality, *i.e.* the delay and unfounded refusal of the NFA Administrator to comply with the directives of the NFA Council, need not cause the legitimate traders to be considered and labeled as smugglers, when their requests for extensions are just and within the extension of the period allowed by the NFA Council.

In this regard and on behalf of the NFA Council of which the good Secretary is a member, we seek your assistance on this matter, specifically in addressing the Memorandum issued by the BOC Commissioner.

Additionally, we request that the BOC be directed to furnish the NFA Council, through the DOF, a copy of all import permits filed or forwarded to it in order for the NFA Council to validate the reports of several shipments from Vietnam and Thailand, among others.

Thank you for your consideration and we appreciate the assistance extended to the NFA Council for the welfare of the NFA, legitimate rice importers, and farmers alike.

We look forward to your feedback on the matter.

Pursuant to the letter dated 28 February 2017 of Jason Laureano Y. Aquino, Administrator, National Food Authority (NFA), and the letter dated 02 March 2017 of Lemuel R. Pagayunan, Director, Grains Marketing Operations Division, NFA, the arrival period of rice importations under the Minimum Access Volume (MAV) Program for the year 2016 will only be until 28 February 2017, except for rice importations from Pakistan and India as source countries wherein it has been extended until 31 March 2017.

Accordingly, rice importations coming from countries other than Pakistan and India should be subjected to seizure by the concerned Port.
