

4 DESCRIPTION OF GOOD

"WOW COFFEE - BROWN, PRE-MIX COFFEE"

Based on the ingredients list, product description and certificate of analysis submitted, subject article is a milk coffee mix in powder form. It contains sugar, non-dairy creamer, brown sugar, instant coffee, whey powder, maltodextrin, coffee, vanilla and milk flavor, caramel powder, and anti-caking powder. Packed in 25 kg kraft bags, subject article is to be dried to eliminate moisture and repacked into sachets for retail.

5 REASONS FOR CLASSIFICATION

Heading 21.01 of the 2012 ASEAN Harmonized Tariff Nomenclature (AHTN) covers extracts, essences and concentrates, of coffee, tea or maté and preparations with a basis of these products or with a basis of coffee, tea or maté. The pertinent Harmonized System (HS) Explanatory Notes (ENs) state that this heading covers, among others, preparations with a basis of the coffee, tea or maté extracts, essences or concentrates. These are preparations based on extracts, essences or concentrates of coffee, tea or maté (and not on coffee, tea or maté themselves), and include extracts, etc., with added starches or other carbohydrates.

In view thereof, subject article is classified under 2012 AHTN subheadings 2101.12.90A and 2101.12.90B, with an in-quota and out-quota Most Favoured Nation (MFN) rates of duty of 30% and 45% ad valorem, respectively and ASEAN Trade and Goods Agreement (ATIGA) rate of duty of zero, subject to submission of Certificate of Origin (CO) Form "D".

4 DESCRIPTION OF GOOD

"OREAS 502/502B CERTIFIED REFERENCE MATERIAL (CRM)"

Based on the material safety data sheet submitted, subject article is a certified reference material, containing different compositions, such as: crystalline silica (quartz), feldspar, clays (illite, montmorillonite, kaolin), adularia, mica (sericite), carbonate (calcite, dolomite, magnesite), chlorite, iron oxides and sulphides (pyrite, pyrrhotite, arsenopyrite). It is prepared from naturally-occurring gold bearing rocks and base metal ores and contains varying amounts of crystalline silica. Available in either single use packaging (containing 60-gram unit), in robust laminated foil pouches with erasable labels or wide mouth jars, it is accompanied by a certificate indicating the values, methods used to determine the values and degree of certainty. Subject article is used in the mining industry as laboratory standards for testing and checking the performance of the assay.

5 REASONS FOR CLASSIFICATION

Heading 38.22 of the 2012 ASEAN Harmonized Tariff Nomenclature (AHTN) covers, among others, certified reference materials. The pertinent Harmonized System (HS) Explanatory Notes (ENs) state that the certified reference materials of this heading are reference materials prepared for the calibration of an apparatus, the assessment of a measurement method or the assignment of values to a material. These reference materials may consist of the following, among others, materials, whether natural or synthetic, certain properties of which have been accurately determined (e.g., tensile strength, specific gravity). These reference materials must be accompanied by a certificate which indicates the values of the certified properties, the methods used to determine the values and the degree of certainty associated with each value, and the certifying authority.

In view thereof, subject article is classified under 2012 AHTN subheading 3822.00.90 with a Most Favoured Nation (MFN) rate of duty of 1% ad valorem and ASEAN-Australia New Zealand Free Trade Area (AANZFTA) rate of duty of zero, subject to submission to Certificate of Origin (CO) Form "AANZ".



"PIG NIPPLE DRINKERS"

Based on the brochure and product specifications submitted, subject articles are nipple drinkers (waterers) for pigs. These valves, made from stainless steel material, are used by pigs to gain access to drinking water. They have a thread at one end used for attachment to a pipe which is connected to the water source. Their specifications are as follows:
