



4 DESCRIPTION OF GOOD

"SSF-511 FRAC TANK TRAILER, 500 BBL"

Based on the product catalog, equipment specifications and drawing submitted, subject article is a two-wheeled tank trailer having 21,000 galloons (500 BBL) capacity with discharge manifold, circulation line, fill and vent line. The discharge outlets are located at the bottom front end of the tank. A manway is located on curb-side of the unit for maintenance operations. It has an overall length of 540 inches (13,720 mm), width of 102 inches (2,591 mm) and height of 117 inches (2,972 mm). It is used for mixing and storage of fracturing fluids.



5 REASONS FOR CLASSIFICATION

Heading 87.16 of the 2012 ASEAN Harmonized Tariff Nomenclature (AHTN) covers, among others, trailers and semi-trailers. The pertinent Harmonized System (HS) Explanatory Notes (ENs) state that the heading covers a group of non-mechanically propelled vehicles (other than those of the preceding headings) equipped with one or more wheels and constructed for the transport of goods or persons. The vehicles of this heading are designed to be towed by other vehicles (tractors, lorries, trucks, motorcycles, bicycles, etc.), to be pushed or pulled by hand, to be pushed by foot or to be drawn by animals. The heading includes, among others, trailers and semi-trailers. The most important types of trailers and semi-trailers falling in this group are those designed for use with motor vehicles. Trailers usually have two or more sets of wheels, and a coupling system mounted on the swivelling front wheels which steer the vehicles. Semi-trailers are fitted with rear wheels only, the forward end resting on the platform of the towing vehicle to which it is coupled by a special coupling device.

In view thereof, subject article is classified under 2012 AHTN subheading 8716.31.00 with Most Favoured Nation (MFN) rate of duty of 3% ad valorem and ASEAN-Australia-New Zealand Free Trade Area (AANZFTA) rate of duty of zero, subject to submission of Certificate of Origin (CO) Form "AANZ".

4 DESCRIPTION OF GOOD

"OAKITE SUPER RUSTRIPPER"

Based on the chemical composition and technical information submitted, subject article is a highly alkaline stripper compound, in the form of white to yellow powder, consisting of sodium hydroxide, sodium carbonate and sodium hydroxyethylene diamine triacetate. It is to be diluted in water at a recommended concentration of 120 to 600 g/l at temperature of 71°C to a rolling boil (for tank immersion application) or 15 to 60 g/l at 71°C to 82°C (if used as a spray washer). It is used for removing rust, paint, phosphate coatings and shop soils from ferrous metals. Subject article is packed in 25 kg bags.

5 REASONS FOR CLASSIFICATION

Heading 38.10 of the 2012 ASEAN Harmonized Tariff Nomenclature (AHTN) covers, among others, pickling preparations for metal surfaces. The pertinent Harmonized System (HS) Explanatory Notes (ENs) state that these are preparations used to remove oxides, scale, rust or tarnish from the surface of metals, or for roughening these surfaces to facilitate certain operations. The pickling process may be a finishing operation, or may be effected at an earlier stage (to prepare the metal for drawing or extruding operations, for example), or prior to coating the metal, e.g., by galvanising, metallising, tinning, cladding, electroplating, painting, etc. Pickling preparations are usually based on dilute acids (hydrochloric, sulphuric, hydrofluoric, nitric, phosphoric, etc.), and sometimes contain inhibitors which restrict the corrosion of the metal. Some, however, have a basis of alkalis (e.g., sodium hydroxide).

In view thereof, subject article is classified under 2012 AHTN subheading 3810.10.00 with a Most Favoured Nation (MFN) rate of duty of 1% ad valorem, and ASEAN Trade in Goods Agreement (ATIGA) rate of duty of zero, subject to submission of Certificate of Origin (CO) Form "D".
