



4 DESCRIPTION OF GOOD

"ANAVITE POULTRY VITAMIN"

Based on the certificate of formula and product specifications submitted, subject article is a vitamin supplement for poultry, in the form of a light yellow to yellow powder. It contains Vitamins A, D₃, E, K, B₁, B₂, B₆, and B₁₂, nicotinic acid, pantothenic acid, folic acid, biotin, and calcium carbonate. It is indicated for the prevention and treatment of vitamin deficiencies in poultry, to increase their resistance against stress and during disease condition, and for the improvement of their feed conversion efficiency. It is to be mixed at a rate of 175~300 grams per ton of feed, depending on the age and type of poultry. Subject article is packed for retail sale in 25 kg multilayer kraft bags.

The pertinent Harmonized System (HS) Explanatory Notes (ENs) state that this heading covers medicaments consisting of mixed or unmixed products provided they are, among others, in packings for retail sale for therapeutic or prophylactic use. This refers to products (for example, sodium bicarbonate and tamarind powder) which, because of their packing and, in particular, the presence of appropriate indications (statement of disease or condition for which they are to be used, method of use or application, statement of dose, etc.) are clearly intended for sale directly to users (private persons, hospitals, etc.) without repacking, for the above purposes.

In view thereof, subject article is classified under 2012 AHTN subheading 3004.50.21 with a Most Favoured Nation (MFN) rate of duty of 5% ad valorem, and ASEAN Trade in Goods Agreement (ATIGA) rate of duty of zero, subject to submission of Certificate of Origin (CO) Form "D".

DESCRIPTION OF GOOD

"ZAGRO ANAVITE SWINE VITAMIN"

Based on the product label and certificate of formula submitted, subject article is a vitamin feed supplement in powder form containing vitamins A, D, E, K, B1, B2, B6 and B12, biotin, folic acid, nicotinic acid and pantothenic acid with calcium carbonate. It prevents and treats vitamin deficiencies and increases resistance against stress and during disease condition of swine. It is mixed into the feed at a dosage of 0.15 to 0.35 kg per tonne of feed depending on the category of swine diet (e.g., pre-starter, breeder, etc.). Subject article is imported in 25 kg bags.

Heading 30.04 of the 2012 ASEAN Harmonized Tariff Nomenclature (AHTN) covers, medicaments (excluding goods of heading 30.02, 30.05 or 30.06) consisting of mixed or unmixed products for therapeutic or prophylactic uses, put up in measured doses (including those in the form of transdermal administration systems) or in forms or packings for retail sale. The pertinent Harmonized System (HS) Explanatory Notes (ENs) state that this heading covers medicaments consisting of mixed or unmixed products, provided they are in packings for retail sale for therapeutic or prophylactic use. This refers to products (for example, sodium bicarbonate and tamarind powder) which, because of their packing and, in particular, the presence of appropriate indications (statement of disease or condition for which they are to be used, method of use or application, statement of dose, etc.) are clearly intended for sale directly to users (private persons, hospitals, etc.) without repacking, for the above purposes.

4 DESCRIPTION OF GOOD

"CP EASY SNACK HALF-CUT MIDDLE WING"

Based on the customer product sample feedback, product brochure, and sample submitted, subject article is frozen, pre-cooked, seasoned and battered chicken wings. The chicken middle wing is cut into half then marinated, battered, breaded, fried and then frozen. Packed in sealed plastic pouches with a net weight of 350 grams, subject article is oven toasted (4-5 minutes) or deep fried (2-3 minutes) before serving.



5 REASONS FOR CLASSIFICATION

Heading 16.02 of the 2012 ASEAN Harmonized Tariff Nomenclature (AHTN) covers other prepared or preserved meat, meat offal or blood. The pertinent Harmonized System (HS) Explanatory Notes (ENs) state that the heading covers, among others, meat and meat offal prepared or preserved by other processes not provided for in Chapter 2 or heading 05.04, including those merely covered with batter or bread crumbs, truffled, seasoned (e.g., with both pepper and salt) or finely homogenised.

4 DESCRIPTION OF GOOD

"CP COOKING KIT PEPPER KICKS"

Based on the customer product sample feedback, product brochure, and sample submitted, subject article is frozen, pre-cooked chicken leg meat. It is prepared by mixing the chicken meat (cut in small pieces) with the dipping sauce, followed by steaming, and addition of glazing sauce, before vacuum packing, pasteurization, freezing, and packing. Packed in bags with a net weight of 250 grams, it is cooked by putting the inner bag in boiling water for 5-7 minutes or in a microwave for 3-5 minutes before serving.
