Pursuant to the provisions of Section 1603 (f) of the Customs Modernization Act (Republic Act 10863), the Tariff Commission issued an Advance Rulings (AR) on Tariff Classification with Tariff Classification Circulars (TCC/AR) issued on February 27, 2017, for various imported articles, and the same were submitted and reviewed by this Office, summarized as follows:



4 DESCRIPTION OF GOOD

"CP SHRIMP WONTON WITH SESAME SAUCE"

Based on the product brochure and customer product sample feedback submitted, subject article is a food preparation consisting of pasta stuffed with shrimp which are marinated, wrapped, lain in tray and frozen and comes with sesame sauce. It is packed in an inner bag containing 204 grams (144 grams raw wonton and 60 grams sesame sauce). A soup powder is also included in the pack. Before consumption, frozen shrimp wonton is added to 1000 ml of boiling water for 3-3.30 minutes, then drained and sesame sauce added.



5 REASONS FOR CLASSIFICATION

Heading 19.02 of the 2012 ASEAN Harmonized Tariff Nomenclature (AHTN) covers, among others, pasta, whether or not cooked or stuffed (with meat or other substances) or otherwise prepared, such as spaghetti, macaroni, noodles, lasagne, gnocchi, ravioli, cannelloni. The pertinent Harmonized System (HS) Explanatory Notes (ENs) state that the pasta of this heading may be cooked, stuffed with meat, fish, cheese or other substances in any proportion or otherwise prepared (e.g., as prepared dishes containing other ingredients such as vegetables, sauce, meat).

In view thereof, subject article is classified under 2012 AHTN subheading 1902.20.30 with a Most Favoured Nation (MFN) rate of duty of 15% ad valorem and ASEAN Trade in Goods Agreement (ATIGA) rate of duty of zero, subject to submission of Certificate of Origin (CO) Form "D".

4 DESCRIPTION OF GOOD

"CP GOLDEN CRISPY"

Based on the product brochure and customer product sample feedback submitted, subject article is 76% chicken meat that is marinated, battered, pre-cooked by frying before freezing. The marinate and batter consist of wheat flour, thickener, potato starch, wheat starch, hydrolyzed soy protein, soy sauce, humectant, salt, flavor enhancer, raising agent, colour, black pepper extract, tapioca starch and anti-caking agent. Subject article comes in airtight plastic retail pouch having net weight of 1000 grams. It is subjected to frying at 170-175 °C for 3-4 minutes before serving.

In cases where the preparation contains two or more of the products mentioned above, it is classified in the heading of Chapter 16 corresponding to the component or components which predominate by weight. 4 DESCRIPTION OF GOOD

"CP CHICKEN POP WITH HONEY LEMON SAUCE"

Based on the product information submitted, subject article is a frozen leg meat preparation. The chicken meat which is about 83% of the preparation is marinated, battered, breaded, fried, frozen, and packed in 340 g sealed plastic bag. It is further packed in cartons with a sachet of honey lemon sauce. Subject article is fried at a temperature of 170 - 175°C for 3 to 4 minutes before serving.

4 DESCRIPTION OF GOOD

"CP COOKING KIT GLAZED TERIYAKI"

Based on the sample, customer product sample feedback, and technical information submitted, subject article is an oven-steamed, frozen, prepared meal consisting of 52% chicken meat, soy sauce, sugar, water, thickener, fructose syrup, distilled vinegar, flavor enhancer, color, humectant and ginger. Subject article comes in a carton containing 20 bags of 250 grams vacuum sealed plastic pouches.



5 REASONS FOR CLASSIFICATION

Note 2 to Chapter 16 states that food preparations fall in this Chapter provided that they contain more than 20 % by weight of sausage, meat, meat offal, blood, fish or crustaceans, molluscs or other aquatic invertebrates, or any combination thereof.

Heading 16.02 of the 2012 ASEAN Harmonized Tariff Nomenclature (AHTN) covers other prepared or preserved meat, meat offal or blood. The pertinent Harmonized System (HS) Explanatory Notes (ENs) state that this heading covers all prepared or preserved meat, meat offal or blood of the kind falling in this Chapter, except sausages and similar products, meat extracts and meat juices.

In view thereof, subject article is classified under 2012 AHTN subheading 1602.32.90A, with a Most Favoured Nation (MFN) rate of duty of 40% ad valorem and ASEAN Trade in Goods Agreement (ATIGA) rate of duty of zero, subject to submission of Certificate of Origin (CO) Form "D".

"CP EASY SNACK TEMPURA CHICKEN"

Based on the product brochure and customer product sample feedback submitted, subject article is 38% chicken meat that is seasoned, then mixed with chicken skin, battered, breaded, pre-fried then roasted and frozen. Subject article comes in airtight plastic retail pouch having net weight of 350 grams. It is subjected to frying at 170-175 °C for 1.30-2.30 minutes before serving.
