Pursuant to the letter dated 28 February 2017 of Jason Laureano Y. Aquino, Administrator, National Food Authority (NFA), and the letter dated 02 March 2017 of Lemuel R. Pagayunan, Director, Grains Marketing Operations Division, NFA, the arrival period of rice importations under the Minimum Access Volume (MAV) Program for the year 2016 will only be until 28 February 2017, except for rice importations from Pakistan and India as source countries wherein it has been extended until 31 March 2017.

Accordingly, rice importations coming from countries other than Pakistan and India should be subjected to seizure by the concerned Port.




