## April 25-28, 2017 Report Port of Zamboanga

The Bureau of Customs, XIth Collection District has recorded a total of 85 importation entries (1 formal and 84 informal entries) from April 25-28, 2017. While 11 entries were recorded on the export division.

Records also reveal that no balikbayan boxes was sent during the week. No auctioned shipments as well as shipments scheduled for auction reported.

The port has also issued one (1) alert order and warrant of seizure and detention to an unknown claimant.

The apprehending team of this port was able to apprehend about 392 boxes of cigarettes with an estimate value of 3.8 million pesos.
