NOTICE OF OVERSTAYING CARGOES

Pursuant to Section 1129 of the Customs Modernization and Tariff Act (CMTA) and CMO No. 16-2019 on Guidelines on the sending of Notice under the same, let this be a **Final Notice** to all owners of overstaying cargoes stored at **OCEANLINK CONTAINER TERMINAL CENTER INC.**, per list submitted by the Piers Inspection Division (PID), to the Office of the Deputy Collector for Operations – Port of Manila.
