## NOTICE TO ALL APPLICANTS FOR HIRING AND PROMOTION RE: SUBMISSION OF APPLICATION REQUIREMENTS FOR THE MARCH & APRIL 2022 PUBLICATIONS OF VACANT POSITIONS IN BOC

- 1. This is to reiterate that the CSC-approved Customs Memorandum Order No. 27 – 2016 otherwise known as the Revised Guidelines and Procedures in Hiring and Promotion of Personnel for First and Second Level Positions, including Executive Managerial Positions, in the Bureau of Customs (BOC), substantially provides in part that:
  - $6.3.2 \times \times \times$  an applicant who fails to submit the supporting documents on the set deadline shall be excluded from the evaluation.
- 2. Relative thereto, the BOC HRMD has initially evaluated the documentary requirements for the March and April 2022 publications submitted by the applicants concerned on or before the set deadline.
