WARRANT OF SEIZURE AND DETENTION

WHEREAS, at about 11:03 a.m. of 09 February 2023, personnel of 2nd Provincial Mobile Force Company, Malabang Municipal Police Station led by PLT Francis John Taca-an, in coordination with RMFB14 and MBLT2 (Philippine Marines), apprehended one hundred sixteen (116) boxes of assorted brand of smuggled cigarettes unloaded from an unidentified motorized pump boat docked at a shoreline of Brgy. Tambara, Malabang, Lanao del Sur;

WHEREAS, on 10 February 2023, PNP-Malabang turned over the confiscated cigarettes to the Bureau of Customs, Port of Cagayan de Oro for custody and safekeeping pending the issuance of Warrant of Seizure and Detention (WSD);

WHEREAS, assigned Customs Examiners, John Rey S. Banaynal and Sharief M. Macud, in the presence of ESS and CIIS representatives, conducted inventory of the subject items and yielded the following:

WHEREAS, issuance of Warrant of Seizure and Detention against the cigarettes was recommended for violation of Section 1113 (f) and (l) – 5 of the CMTA;

NOW THEREFORE, by virtue of the authority vested in this Office in accordance with Republic Act 10863 (Customs Modernization and Tariff Act) and relevant Customs rules and regulations, you are hereby directed to seize the **one hundred sixteen (116)** boxes of assorted brand cigarettes and turn-over them to the Property Custodian/Warehouse – in -Charge, this Port, for safekeeping pending termination of the

seizure proceedings thereon or until further order from this Office pursuant to and in strict compliance with the provisions of CMO 8-94 particularly on the matter of making a return of service and the submission of the Inventory Report or list of the articles seized.
