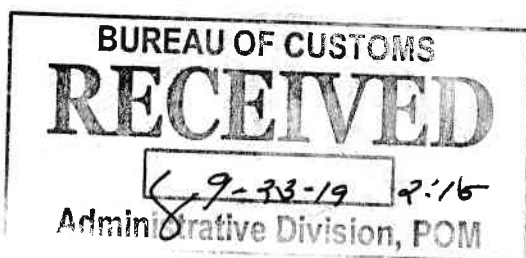
NOTICE OF OVERSTAYING CONTAINERS

Pursuant to the instruction of the Office of the Commissioner to immediately dispose Overstaying Containers at the ATI Container Yards and for the issuance of Decrees of Abandonment of the same under Section 1129 of the Customs Modernization and Tariff Act (CMTA), let this be a **Final Notice** to all owners of overstaying containers stored at ATI-ICD, Laguna, per list submitted by the Asian Terminals, Inc. (ATI), to the Auction and Cargo Disposal Division (ACDD) – Port of Manila. (attached herein)

Ten (10) days upon posting of the same at the Bulletin Board of the Port of Manila and BOC website the said containers will be declared abandoned by the District Collector and accordingly will be issued Decrees of Abandonment pursuant to the provisions of the CMTA.
