### DECREE OF ABANDONMENT

**WHEREAS**, on December 27, 2022, the District Collector, this Port issued the Closure Order of Royal Gloves Phils., operator of CBW No. M1412;

**WHEREAS**, in a Memorandum dated January 10, 2023, in connection with the issued Closure Order of Royal Gloves Phils., the assigned Customs Warehouseman submitted the inventory report of remaining unliquidated bonded raw materials. (Please see inventory report dated July 30, 2022)

**WHEREAS**, in a Disposition Form dated January 17, 2023, the Deputy Collector for Operations, recommended the issuance of Decree of Abandonment against the raw materials pursuant to Section 16 of CMO 03-2022.

**WHEREAS**, in a Memorandum dated January 27, 2023, the Chief Atty. Jose D. Lagac, Jr., MMBWD, forwarded to this Office, the list of remaining unliquidated bonded raw materials covered by WSAD No. W5248-21, W6410-21, W8805-21, W8858-21, and W9429-21 stored at warehouse located at 249 A. Mabini St., Barangay San Antonio, San Pedro, Laguna, for issuance of Decree of Abandonment.

**WHEREAS**, Section 16 of CMO 03-2022 provides that:

**"Section 16. Abandonment of Bonded Goods.** Bonded goods not withdrawn for manufacture or finished goods not exported within the prescribed storage period shall be considered abandoned and proceeded against pursuant to existing rules and regulations. The CBW Operator may, before the expiration of the storage period, expressly abandon his right over the bonded goods in favor of the government."

**WHEREAS**, the remaining unliquidated bonded raw materials are deemed abandoned and subject for turn over to the Auction and Cargo Disposal Division (ACDD), this Port, for proper disposal;

**WHEREAS**, Section 1129 (e) of the Customs Modernization and Tariff Act (CMTA), provides, to wit:

"Section 1129. Abandonment, Kinds and Effects of. – Imported goods are deemed abandoned under any of the following circumstances;

e) when the owner or importer fails to claim goods in customs bonded warehouse within the prescribed period.

**WHEREFORE**, in view of the foregoing, the remaining unliquidated bonded raw materials are hereby declared **ABANDONED** in favor of the government pursuant to Section 1129 (e) of the CMTA.

Let copies of this Decree of Abandonment be furnished to all parties and offices concerned for their information and guidance.
