URGENT NOTICE TO FILE ENTRY

**Attention: IMPORTERS/CONSIGNEE/OWNERS
INTERESTED PARTIES AND ALL OTHERS CONCERNED**

Pursuant to Section 1129 of R.A. No. 10863, otherwise known as, Customs Modernization and Tariff Act (CMTA), upon the failure of the owner, importer, consignee or interested party to file the necessary import entry within a period of (15) days from the date of discharge of the last package from the carrying vessel/aircraft, the shipment shall be considered abandoned, unless extended upon valid grounds for another (15) days pursuant to sec. 407 of the CMTA.
