

## URGENT NOTICE TO LODGE GOODS DECLARATION

## ATTENTION: IMPORTERS/CONSIGNEE/OWNERS/ INTERESTED PARTIES AND ALL OTHERS CONCERNED

Pursuant to Section 1129 of R.A.
