**RECOMMENDED FOR ISSUANCE OF DECREE OF ABANDONMENT**

**February 14, 2020**

Pursuant to Section 1129 of R.A. No. 10863, otherwise known as the Customs Modernization and Tariff Act (CMTA), upon the failure of the owner or interested party to file the necessary import entry within a period of seven (7) days from the date of discharge of the last package from the carrying vessel/aircraft, the shipment shall be considered abandoned, unless extended upon valid grounds for another seven (7) days pursuant to Sec. 407 of the CMTA. Herewith are Bill of Ladings with no entries filed as of February 14, 2020 (Please disregard this Notice if you have already filed the declaration within the prescribed period.)
