

4 DESCRIPTION OF GOOD

"WEILIN™ CHICKEN LUNCHEON MEAT"

Based on the product specifications, ingredients list, product label, certificate of analysis, and photograph of the product submitted, subject article is a canned chicken luncheon meat containing mechanically-separated chicken, chicken meat, water, corn starch, salt, spices, sugar, and sodium nitrite. Packed in 340-g cans, subject article is fully cooked and ready to be eaten, or can be heated as desired before serving.



5 REASONS FOR CLASSIFICATION

Heading 16.02 of the ASEAN Harmonised Tariff Nomenclature (AHTN) 2022 covers other prepared or preserved meat, meat offal, blood or insects. The pertinent Harmonized System (HS) Explanatory Notes (EN) state that this heading covers all prepared or preserved meat, meat offal, blood or insects of the kind falling in this Chapter, except sausages and similar products (heading 16.01), meat extracts and meat juices (heading 16.03). The heading covers, among others, meat and meat offal prepared or preserved by other processes not provided for in Chapter 2 or heading 05.04, including those merely covered with batter or bread crumbs, truffled, seasoned (e.g., with both pepper and salt) or finely homogenised.

In view thereof, subject article is classified under AHTN 2022 subheading 1602.32.90, with a Most Favoured Nation (MFN) rate of duty of 40% ad valorem and ASEAN-China Free Trade Area (ACFTA) rate of duty of 40% ad valorem, subject to the submission of Certificate of Origin (CO) Form "E".

This ruling shall be valid for five years from the date of issuance and shall continue to apply unless the law, facts, or circumstances supporting this ruling have changed.
