Please be further informed of the pertinent provisions of Customs Memorandum Order (CMO) No. 4-2018 (A) which provides:

- 6.3 During the Preliminary Conference the following shall be discussed:
 - 6.3.1 Defining and simplifying the issues of the case;
 - 6.3.2 Entering into admission or stipulation of facts;
 - 6.3.3 Marking of exhibits;
 - **6.3.4** The possibility of disposition of the goods pending forfeiture proceedings in case of perishable articles;
 - 6.3.5 The possibility of settlement; and
 - **6.3.6** Dates for submission of respective Position Papers of the parties.
- **6.4** The Hearing Officer shall require the Claimant to submit its verified Position Paper within five (5) days from the termination of the preliminary conference, copy furnished the Government Prosecutor. Failure on the part of the Claimant to submit its verified Position Paper within the prescribed period shall be deemed waiver on its part to submit the same. No Motion for Extension shall be allowed.

WARRANT OF SEIZURE AND DETENTION

Greetings!

WHEREAS, on 12 December 2022, a shipment bound to Waterloo, Australia (Consignee: Juba Inday) under House Airway Bill No. 770739239673 said to contain "STRUCTURAL TOYS" under the name of TEVITA WAISU with address at Kamenn Toys Enterprises 55 McDonalds Gil Puyat Dian Makati 1235 PH (Contact No.: 639695919828) arrived at the Federal Express (FedEx) gateway facility and marked for verification/physical examination by the X-ray Inspector on duty;

WHEREAS, on 22 March 2023, a Mission Order was issued directing Trade Control Examiners to conduct inventory of various shipments for export containing cigarettes;

WHEREAS, on 24 March 2023, Trade Control Examiner Maria Annalou Pojas conducted physical examination on the subject shipment in the presence of representatives from Phillip Morris Fortune Tobacco Company, Inc. (PMFTC), Customs Intelligence and Investigation Service (CIIS), Enforcement and Security Service (ESS) and FedEx with the following findings:

3 PCS. STRUCTURAL TOYS	Twenty-five (25) reams of Shuangxi Cigarettes
Value: USD 300.00 Gross Weight: 7.3 kgs.	

WHEREAS, on 24 April 2023, the Office of the District Collector received a Memorandum of even date from Ms. Maricar N. Go and Ms. Pojas, Officer-In-Charge (OIC) Export Unit

and Trade Control Examiner FedEx-Export, respectively, thru Atty. Lilibeth Sandag, Deputy Collector for Operations, recommending the issuance of a WSD against the subject shipment based on the discrepancy between the goods found during the physical examination and goods declared in the commercial invoice for violation of Section 1113 paragraph (I) (3) and (4) of Republic Act (R.A.) No. 10863 otherwise known as the Customs Modernization and Tariff Act (CMTA) in relation to National Tobacco Administration (NTA) Memorandum Circular No. 002, Series of 2020;

WHEREAS, upon evaluation thereof, this Office finds probable cause for the issuance of WSD against the subject shipment for violation of Section 1113 paragraphs (f) and (l) (3) and (4) of R.A. No. 10863 otherwise known as the CMTA in relation to NTA Memorandum Circular No. 002, Series of 2020;

WHEREFORE, by virtue of the power vested in me by law, and in compliance with pertinent Customs laws, rules and regulations, you are hereby ordered to forthwith seize the aforementioned articles and take custody over the same pending termination of the seizure and forfeiture proceedings and/or until further order from this Office. In this connection, please be guided by Customs Memorandum Order No. 8-84, particularly on the matter of making a return of service and submission of inventory of list of the subject articles.
