# MESSAGE OF THE SECRETARY



Let me first congratulate the Bureau of Customs for exceeding its target in the last quarter of 2016. It is not usual for our main revenue agencies to surpass the volume of collections set for them. I hope this achievement becomes habitual for the Bureau.

Surpassing the collection target is not the product of chance. It is the result of reforms instituted in the Bureau aimed at improving transparency, raising efficiency and modernizing systems. These reforms were undertaken within the framework of the Customs Modernization and Tariff Act (CMTA) and should be sustainable deep into the future.

The installation of CCTVs in our ports and the successful computerization of procedures to create a digital trail of transactions appear to be working well. I am more than honoured to be part of the Bureau of Customs. It is a feat that is coupled with reforms brought by the combined efforts of our officials, employees, and stakeholders.

The Bureau has come a long way in providing genuine public service to the Filipino people. Since the start of the new administration, the Bureau has witnessed positive changes. We now enjoy an improved revenue collection -- in fact, we have exceeded our target for the last quarter of 2016. For the second semester of CY 2016, the BOC registered its collection performance of P207.363 billion which is 9% higher than the first semester's performance of P191.048 billion. Significantly, twice during the last six months of 2016, November and December, the BOC was able to exceed its monthly targets.

In November 2016, we registered a 110% performance against said month's target and 101% in December.

I salute all men and women in the Bureau who perform their duties with honesty, integrity, and a strong sense of accountability to keep our fight against corruptionalive. We have already filed cases against dishonest employees and stakeholders, and have suspended the accreditation of erring brokers and importers. We are assuring that we are in one with President Duterte in promoting a corrupt-free government.

This new year proves to be an exciting one for the agency. We continue to draft more policies for the efficient implementation of our Customs Modernization and Tariff Act, and await the approval of the implementing rules and regulations of the Anti-Agricultural Smuggling Act, among others. 
# COLLECTION PERFORMANCE



BOC's revenue continuously grew amid stronger tax enforcement. The collection report for 2016 shows a total collection of P398.411 billion, attaining 97.4 percent of the P409.0 billion collection target for the year. It is also remarkable to note that twice during the last six months of 2016, the BOC was able to exceed its monthly target.

The combined cash and non-cash collection for 2016 is P30.877 billion, or 8.4 percent higher than the 2015 collection. Cash collection of P390.659 billion, which is another record breaking performance as it exceeded the 2015 cash revenue by P33.254 billion or 9.3 percent. It also cushioned the 23.5 percent drop in Tax Expenditure Fund due to lower rice importation subsidized by the government.



Based on the major source of collection, oil used to contribute more or less 30 percent to the total BOC collection. However, due to the drop in oil price up to the 3rd quarter of CY 2016, total BOC collection from crude and petro products decreased from P62.2 billion to P51.5 billion, or 17.2 percent, and its contribution to the total collection for the year was reduced to 15 percent.

Non-oil, on the other hand, grew by 13.6 percent, from P305.3 billion to P346.9 billion. Top commodities in terms of duties and taxes paid includes 1) Motor Vehicles, 2) Foodstuff, 3) Petro Products, 4) Industrial Machineries and Equipment, 5) Electrical Machineries and Equipment 6) Iron and Steel 7) Crude Oil, 8) Organic and Inorganic Chemicals, 9) Plastic/Resin and 10) Pharmaceutical products

## Other observations for 2016 include:

- VAT which comprises 73 percent of total collection, grew by 6.2 percent for the year 2016
- Strong collection from excise tax which grew by 30.4 percent to P41.5 billion on account of higher imports and motor vehicle collection.
- Duties collected grew by 8.4 percent despite lower average tariff rate to 6% and higher percentage of non-dutiable import to total import to 81 percent due to improve valuation.
- Tax credit certificate application and tax refund amounting P4.786 also reduced total revenue collection.
- The conduct of successful public auction of confiscated and abandoned goods amounting P1.009 billion contributed to growth of non-traditional revenue collection.

# **Imports**

The volume of imports continuously grow over the years. Total volume of imports for the period January to December 2016 grew by 8 percent to 104,834,430 metric tons from 97,107,000 metric tons. However, 82 percent of the volume of imports are already non-dutiable. Although commodities continued to come in big volume, the government could no longer rely on them as far as generating revenues is concerned.

Likewise, total value of imports for the period January to December 2016 grew by 14 percent, to P4,543,366 from P4,000,426 in 2015. Non-dutiable Value of Imports however, increased at a higher rate of 15% as more commodities enjoyed zero tariff in compliance with various

international, multilateral and bilateral agreements, while Dutiable Value of Imports increased by 9 percent. The increase in the percentage share of non-dutiable value of imports to total imports to 81.1 percent from 80.4 percent in 2015 resulted to drop in duties collection due to narrowing tax base. For imports covered by various free trade agreements alone, a total of 1.263 trillion value of goods flowed into the country during the year, resulting in P135.361 billion in foregone duties.

# BOC forms committee to meet collection target


The Bureau of Customs has created on August 2 the Committee on Revenue Enhancement (CORE), pursuant to Customs Memorandum Order (CPO) No. D-23-2016, that will address the huge shortfall in revenue collection in the first half of 2016 and help it reach its target collection for the same year.


It was created to ensure that the Bureau will meet its 2016 revenue collection target of P498 billion. It was tasked to study the daily performances of all ports, identify the challenges on collections, create strategies and guide assessment officials to maximize revenue collection.

Heading the committee is Director Cecile Marie Soriano, the Bureau's statistician and chief of the Financial Services Office.

## **Revenue from Auction**

Proceeds from auction conducted in various ports posted a total of P897, 689, 341. 49. The Manila International Container Port yielded the highest proceeds from auction at P292, 507, 014.32 followed by Port of Manila gaining a total revenue auction of P290, 791, 218.32. The Port of Subic came in at third with auction proceeds of P147, 243, 595.20





# **Apprehensions**

A total of 413 Alert/Hold Orders and 56 requests for "Special Stop" were issued by the Intelligence Group for the year 2016 against various shipments nationwide suspected to have the following violations: misdeclaration, misclassification, undervaluation, lack of import permits from the appropriate government regulatory agencies, intellectual property rights and other customs offences.

Of these, 88 alert/hold orders resulted to the issuance of Warrants of Seizure and Detention (WSD) while 24 alert/hold orders culminated in the institution of abandonment proceedings against shipments valued at P1,002,489,412.26.

About 413 of the alert/hold orders issued resulted to the collection of additional duties and taxes plus marking duties or surcharges amounting to P113,620,217.99.

All in all, the collective energies of the entire Intelligence Group for the government's coffers generated the amount of P1,116,109,630.00.

In response to the directive of the President for the intensification of the anti-drug smuggling program, the Intelligence Group seized 960 pcs. of ecstasy tablets and 69 grams of methamphetamine hydrochloride (shabu) with an estimated street value of P2,000,000 at the Ninoy Aquino International Airport (NAIA). The illegal drugs were declared as amino supplements, bicycle frame and footwear to conceal its true nature.

An estimated 1,000 pcs. of peach-colored tablets embedded with "TESLA" and "C/P" markings were found in a black plastic bag in NAIA on August 24, 2016. These tablets were found to be a form of the illegal drug methylenedioxy methamphetamine or more popularly known as "ecstasy tablet" and were estimated to be worth P1,200,000.00.

Meanwhile, the Enforcement Group-X-Ray Inspection Project was able to alert 17 shipments from seaports, and held 2,139 baggages from the airports. Out of the alerted shipments, 18 were issued corresponding Warrant of Seizure and Detention, and four were referred to the Command Center.

These apprehensions were based on the image scanning done thru the use of the X-Ray machines, which are utilized to aid in finding and verifying suspected shipments or baggage.

# **Cases Resolved**

Despite its very limited personnel capacity of only three lawyers and six investigators, the personnel of the Investigation Division were able to resolve 90 cases for the year 2016. A number of these cases stemmed from anonymous complaints against BOC personnel as well as against other entities who had various transactions with the Bureau.

Of these cases, 42 were completed with its findings or recommendations approved while 47 are still pending approval, with one case returned for reinvestigation.

# **Additional revenue**

Additional revenues were generated in the form of Additional Duties and Taxes imposed against shipments that underwent X-Ray scanning and were found to have paid lower amount of duties as mandated by the CMTA and/or through Settlement/Redemption/Public auction after the issuance of Warrant of Seizure and Detention by the respective Ports through the initiative of the X-Ray Inspection Project (XIP) under the Enforcement Group.

This was made possible because of the close coordination between the XIP Central Office and the XIP Field Offices as far as collecting additional revenues for the Government is concerned.

# BOC uncovers smuggled firearms in Balikbayan Box



The Bureau of Customs has seized various kinds of high-caliber firearms, which came from the United States through a balikbayan box at the warehouse of Atlas Shippers International Inc. (ASSI) at the Ninoy Aquino International Airport (NAIA).

The Bureau officials received an intelligence report about the questionable balikbayan box on July 19. Authorities then started monitoring the shipping of the said parcel from ASSI's warehouse in NAIA to Bacolod City warehouse on August 4 and waited for its claimant. Upon examination, they found inside the box various high-caliber firearms.

The parcel was sent by Maiko Claridad from California, USA, and was consigned to businessman Leo Mendieta of Bacolod City.

The operation has resulted to the arrest of Mendietta (real name Brian C. Ta-Ala) and his aide Wilford Z. Palma on August 6 and were placed under the custody of the CIDG.

# BOC transfers Capt. Baylosis to Sulu

Commissioner Nicanor Faeldon signed on August 23 the Customs Personnel Order reassigning Special Police Captain Arnel A. Baylosis to the Sub-port of Jolo, Port of Zamboanga due to corruption case filed against him before the Department of Justice.

Commissioner Faeldon said that four individuals who had direct transactions with him testified through affidavits that Baylosis has received millions of pesos in bribe since 2012, amounting to at least P100-220 million monthly.

The case was already forwarded to the DOJ for investigation.

# Customs CCTV captures PPA employee in questionable act

An employee of the Bureau of Customs is now under investigation after being spotted on September 5 through the newly installed CCTV cameras, accepting money from importers/brokers in Window 1 of Room 104 of the Port of Manila,

Upon further investigation, authorities found out that the involved employee is from ATI. Although ATI is authorized to receive from brokers or importers or their authorized representatives' payments of wharfage fees -- the final step in filing import entries, prior to release of gate passes -- the Bureau recommends that payment of wharfage fees should be paid once and only through an authorized window.

More than 200 CCTVs were installed in port offices as part of government's efforts to promote transparency and to curb corruption. Commissioner Nicanor Faeldon believes that this is an effective measure in instilling honesty among BOC employees.

# BOC creates Command Center for operations



The Bureau of Customs has centralized its operations with the creation of a new Command Center, pursuant to the Customs Special Order (CSO) No. 45-2016 signed by Commissioner Faeldon.

The Command Center (COMCEN) shall provide the Commissioner with situational awareness of all collection districts, sub-ports, law enforcement and regulating agencies, customs stakeholders and open source media.

Coordination with Philippine Navy, Philippine Coast Guard, Philippine Ports Authority, Philippine Air Force, Civil Aviation Authority of the Philippines, Air Transportation Office and other related maritime and aerospace agencies is also among its mandate.

COMCEN shall also facilitate in the verification and effective liaising with government regulatory agencies and private entities that issue import documents, permits and certifications.

It is created to act as a central governing body that will monitor, coordinate, and supervise different aspects of customs administration, including daily operations of the principal ports of entry and sub-ports.

# BOC conducts drug testing for Intelligence & Investigation agents

The Bureau of Customs has started conducting random drug tests on its 88 Customs Intelligence and Investigation Service (CIIS) agents on October 14 in support of President Rodrigo Duterte's campaign against illegal drugs.

The 88 agents who participated in the drug tests are from the Office of the CIIS Director; Administrative and Support Unit; Production Section; Investigation Division; Intellectual Property Rights Division; Port of Manila; Harbor Center; Manila International Container Port; North Harbor; Ninoy Aquino International Airport; Risk Management Office; and Trade and Transparency Unit.

Agents from the ports of San Fernando, Batangas, Subic, Clark, and Limay are also invited in the random drug tests.

# BOC welcomes order on lifestyle check of officials

The Bureau of Customs welcomes the order of Finance Secretary Carlos Dominguez III to submit all government officials and employees to lifestyle check to be conducted by the Department of Justice (DOJ) thru the National Bureau of Investigation (NBI).

Commissioner Nicanor Faeldon believes that the move is one way to weed out dishonest personnel in the Bureau, in compliance with President Rodrigo Duterte's goal to eliminate corruption within the agency.

To date, around 18 cases involving employees of the Bureau have been investigated, with 14 cases already forwarded to the DOJ.

One official, Atty. Arnel Alcaraz, was relieved on November 2 as OIC of the Enforcement Group following a graft case filed before the NBI against him for alleged extortion activities.

"This is a problem that we are fixing. And we have to show the public that we are very transparent," Commissioner Faeldon said.

# **Strengthening Anti-Smuggling Efforts**

In August 2016, the Bureau issued Customs Special Order No. 44-2016 creating the Special Studies and Project Development Committee (SSPDC) to prevent smuggling and other fraudulent customs activities to further ensure the successful institution of reforms.

On December 18, with the combined forces of SSPDC, Collection District Port of Limay, Coast Guard and PNP Limay, we seized a total value of P700 million smuggled oil. Two oil tankers were also seized and ordered forfeited.

Then, BOC also intercepted three vessels carrying 17,100 sacks of smuggled rice with an estimated total value of P18.5 million.














# TOTAL VALUE 7.3 BILLION SEIZED SMUGGLED GOODS

# **BOC** to implement system vs. import value misdeclaration


The Bureau of Customs is now transcending from the manual implementation of the value reference of imported commodity to an electronic platform in order to capture all trade transactions and monitor the valuation of import commodities to combat import undervaluation.

This electronic platform is also known as VRIS or Value Reference Information System, which sets the value threshold or standard of every imported commodity based on historical value of previous importations and prevailing market values and statistical studies.

The VRIS is a system that monitors and coordinates values of import commodities that come in the country. Through this, the Bureau can monitor those importers declaring below the reference value, thus preventing them from smuggling commodities.

The BOC has yet to finalize the system and will implement this on the first quarter of 2017.

## **Accreditation**

As of December 31 2016, the regular importers and customs brokers with active customs accreditation are as follows:

- Regular Importers 11,510
- Customs Brokers 1,613

Within the period of October 10 to December 31, the customs accreditation of 20 importers were suspended and/or withheld based on non-existence of declared office address, returned written communications, spurious/questionable documents submitted, non-declaration of importations in list of importables and violation of the existing conflict of interest policy (importers engaging in the customs brokerage and/or freight forwarding business and customs brokers engaging in the importation business, without proper delineation).

All Account Management Office (AMO) personnel were directed to decline any valuable consideration, monetary or otherwise. Within this period, there were three (3) AMO personnel, who had to be relieved and/or transferred. Replacements thereto were primarily based on zero customs experience in order to ensure against familiarity with stakeholders.

# **Modernization**

Since the signing of the Customs Modernization and Tariff Act (CMTA), BOC has released its Implementing Rules and Regulations (IRR) through Customs Administrative Orders (CAOs) on salient provisions of the law:

- Imported Goods with De Minimis Value not Subject to Duties and Taxes (CAO 2-2016)
- Establishment of an Advance Ruling System for Valuation and Rules of Origin (CAO 3-2016)
- Consolidated Shipment of Duty and Tax-Free "Balikbayan Boxes" (CAO 5-2016)
- Conditionally Tax and/or Duty Exempt Importation of Returning Residents and Overseas Filipino Worker (CAO 6 – 2016)

ICT-related goods and services were procured to speed up and secure credibility in data gathering and analysis. The Data Warehouse Analytics software was procured and is customized for more efficient statistical analysis, data mining, forecasting, and trend analysis. It is also intended for use in historical data analysis, dashboard reporting and other related functionalities.

The Commissioner of Customs Nicanor Faeldon signed Customs Special Order (CSO) No. 36-2016 last August 3 to streamline new procedures on all duty drawback, Value-Added Tax (VAT) and excise tax claims to speed up transactions in the Bureau.

The said CSO abolishes the Tax Credit Secretariat and reverts duties and responsibilities concerning tax credit and/or refund from the Deputy Commissioner of the Revenue Collection Monitoring Group to the Office of the Commissioner.

The following are the new procedures:

- 1. Claims for duty drawback endorsed by the One-Stop-Shop of the Department of Finance (OSS-DOF) or approved claims for refund of VAT and/or Excise Tax coming either from OSS-DOF or Bureau of Internal Revenue (BIR) shall be received at the Office of the Commissioner for recording. It will then be forwarded to the Revenue Accounting Division (RAD) for payment verification and checking of documents.
- 2. The RAD will then issue a certification attesting to the payment of the duties and taxes on the shipments subject of the duty drawback or refund for VAT/Excise tax and its remittance to the Bureau of Treasury.
- 3. For VAT/Excise Tax refund, the RAD shall endorse the entire docket of the claim to the Accounting Division of the Financial Management Office (FMO) for confirmation of the amount due as refund based on the RAD-issued Certification.
- 4. The Accounting Division shall then prepare the Disposition Form and Tax Credit Certificate, bearing the final due amount for refund, and forward the same to the Office of the Commissioner for the Commissioner's signature or any of his authorized representatives.
- 5. The signed Tax Credit Certificate shall be endorsed back to the Accounting Division for release to the claimant or his/her authorized representative.

RAD shall provide administrative and technical assistance in the processing of all drawback, VAT and other refund claims, including the keeping of a central records system. The RAD Chief is also authorized to issue Tax Debit Memo (TDMs) under the Bureau's E2M System, and is required to submit a monthly report on all claims received and processed.





Two hundred participants interacted with the government, commercial and academic counterparts from around the world in the 11th Annual World Customs Organization (WCO) Partnership in Customs Academic Research and Development (PICARD) Conference at the Manila Hotel last September 27 to 29.

Hosted by the Bureau of Customs (BOC), the 11th PICARD focused on the presentation of research and policy analysis by academics and practitioners on topics integral to Customs and international trade.

Other speakers who gave their opening remarks were Department of Finance Undersecretary Antonett Tionko, WCO Secretary General Kunio Mikuriya, and Academy of Developmental Logistics Director Samuel Bautista.

# BOC reiterates 'no opening of balikbayan box' policy

Commissioner Nicanor Faeldon reiterates to the OFWs that Bureau's personnel are no longer allowed to physically inspect balikbayan boxes.

Such directive is in line with CMO 27-2015 which states that balikbayan boxes of OFWs shall not be subjected to random or arbitrary physical inspection, and instead shall only undergo mandatory x-ray scanning.

In cases of shipments marked after x-ray examination, the inspector shall recommend the issuance of an Alert Order. The box/es shall then be subjected to 100% physical examination at an authorized examination area to be conducted by a Customs Examiner in the presence of the apprehending officers, freight forwarder consolidator, representatives of the Overseas Workers Welfare Administration (OWWA) and/or a designated officer of an OFW association.



# BOC: Delays in trade facilitation caused by various factors

Commissioner Nicanor Faeldon reiterates that there are factors arising from other entities other than the processing in the bureau that contribute to transaction delays that deprive importers and the Bureau of more revenue.

He identified offices such as the Philippine Ports Authority (PPA), Asian Terminals Inc. (ATI), and International Container Terminal Services Inc (ICTSI) as in-charge of port operation, cargo handling and tracking, and port development.

Faeldon claimed that the Bureau has no control over the 54 regulating agencies as well as the private entities.

# BOC partners with civil society groups to promote transparency



The Bureau of Customs together with civil society organizations Coalition of Clean Air Advocates of the Philippines (CCAAP), United Filipino Consumers and Commuters (UFCC), Green Team Luntiang Pangarap, and Santinig Philippines signed a memorandum to promote transparency in the bureau.

This move shall pave way for the transparency of Customs in all its records to the transacting public and to the civil society groups.

Deputy Commissioner Arturo Lachica explained the vital role of access to information in fighting all forms of graft and corruption in the government. To ensure public trust, the government must establish a system of transparency, hence BOC allowed civil society groups to access records that are vital to public information.

Earlier initiatives of the Bureau for transparency include the installation of CCTV cameras in the agency's frontline offices and the online livestreaming of these cameras.

## BOC on regulatory agencies: revisit rules on issuance of import permits

To curb meat smuggling in the country, Commissioner Nicanor Faeldon encouraged regulatory offices to revisit their process of issuing importation permits during the induction ceremony of the National Federation of Hog Farmers on December 7.

A UN report showed that the bulk of imported meat products which entered the country were declared as offal. Offal only has a 5 percent tariff, as compared to the 40% tariff for meat -- resulting in a high number of smuggled frozen meat through misdeclaration of meat imports.

However, Faeldon clarified that the bureau has no mandate over regulatory permits thus responsible on the assessment and checking of the completeness of all the requirements issued by the regulatory offices.

He also encouraged other regulatory agencies to participate in the advocacy of reforming the process of importing products in the country.

For 2016, the Bureau of Customs continuously pursued reforms toward meaningful transformation with the end view to serve the public with clean and honest governance. It shall move in that direction in the days ahead.

# **EXECUTIVE PROFILE**



**Nicanor Escalona Faeldon** is the 38th commissioner of the Bureau of Customs. He assumed office on June 30, 2016 after he was appointed by President Rodrigo Roa Duterte.

Faeldon was born on July 29, 1965 in Batanes. As a kid, he dreamed of becoming a soldier, but his parents -- who were both in the education sector -- expressed their objection. He took up Political Science instead at the National University and graduated in 1989.

Because of his determination to pursue his original ambition, he attended military courses after graduating from college. He was eventually called into active duty at the Philippine Marines in 1992. In his time serving at the Marine Corps, he was awarded a Gold Cross Medal, three Military Merit Medals, five Military Commendation Medals, a Wounded Personnel Medal, and Luzon, Visayas and Mindanao campaign medals.

His simple dream to serve in the military has grown into a passion to serve the country. He is the brains behind Pilipino.org which aimed to create "greater national consciousness to achieve nationhood", and the youth-lead Kalayaan Atin Ito which asserts Philippines sovereign rights over the West Philippine Sea. He also made rounds in schools to encourage students to join in fighting corruption in the government.

It is the same fight that Faeldon hopes to achieve in the Bureau of Customs. Along with his trusted men, Faeldon is now entrusted to reform the agency and improve its services.



**Ariel F. Nepomuceno** has established himself as a respectable leader over the past years. His leadership competence had been perfected by serving as a manager, a director and a vice president among others. As a hands-on leader, he personally engaged himself in planning, directing, supervising and managing the over-all operations and company's internal administration. He pioneered the establishment of different organizations, formulated company policies and procedures and performed other functions not limited to the foregoing. In addition, he is skilled in conducting researches related with intelligence and security management for government organizations and private corporations.

Prior to his appointment as BOC Deputy Commissioner of the Enforcement Group, Nepomuceno headed various offices as he was the Director of Office of the Civil Defense, DND; Head of the Bids and Awards Committee, Office of the President-Office of the Presidential Chief of Staff; Executive Vice President, General Manager of Food Terminal Incorporated and Vice-President for Operations at Avalon Pacific Corporation inter alia.

In March 1990, Nepomuceno received his Bachelor of Arts Degree with flying colors as Magna cum Laude at the University of the Philippines, Diliman. Also, he received awards such as Most Outstanding Graduate in the Social Science, Presidential Scholarship Awardees of 1989-1990, College of Law-UP, Science of Mind Scholarship Awardees of 1987-1989, UP and Pi Gamma Mu- Phi Kappa Pi International Honors Awardees of 1990, UP.

Deputy Commissioner Ariel Nepomuceno is also a member of the Philippine Military Academy Class of 1987 and a reserve officer of the Philippine Air-Force with the rank of Major.



**Atty. Teddy Sandy S. Raval** is the Deputy Commissioner of the Intelligence Group. Raval has worked with the Bureau of Customs for 10 years.

Prior to entering the government service, he worked as a private-practice lawyer in a law firm. In 2007, an opportunity for him to work in the Bureau has opened. His career started as one of the lawyers at the Legal Service under the Revenue Collection and Monitoring Group.

Years after, he was given another opportunity to be one of the Investigators for Internal Inquiry and Prosecution Division of the Customs Intelligence and Investigation Service. In 2010, he was appointed Assistant Chief then later to Chief of the Intellectual Property Rights Division.

He has also worked as Director for Enforcement and Security Service prior to his appointment as Deputy Commissioner of the Intelligence Group.

Set to retire from public service, he was appointed as Undersecretary of the Department of National Defense and served from 2013 to 2016.

Now as Deputy Commissioner, Ecarma manages to keep himself active in practical shooting, skydiving and scuba diving, among others and still finds time to do charity work through the Gawad Kalinga Program.



Atty. Edward James A. Dy Buco was an elder at the Mandaue City Alliance Church. He finished his Juris Doctor degree at the Ateneo de Manila University Law School. He rendered public service as Provincial Board Member in Antique, and worked with the Bureau of Customs for 12 years. He was also a professor of law. He lives in Mandaue City, Cebu with his wife and children. In his free time, he writes songs and plays the saxophone.

From November 2012 to January 2014, he served as Deputy Collector for operations of BOC Davao. He was also named officer-in-charge of the Davao District from April to June and became Chief of Staff of the same district from November 2011 to November 2012.

Atty. Dy Buco is currently the Deputy Commissioner for Assessment and Operations Coordinating Group. He was appointed last December 8, 2016.





# **ORGANIZATIONAL STRUCTURE OF THE BUREAU OF CUSTOMS**




