This refers to the herein attached ABANDONMENT PROCEEDING NO. 030-2023 (NAIA): Forty-Two (42) overstaying shipments which remained unclaimed at PAIRCARGO FACILITY, CBW No. 83.

As the consignees/claimants of the aforementioned overstaying shipments failed to claim their respective shipments despite due notice, this Office deems it practicable to cause the electronic posting in the Bureau's official website a copy of the issued Notice and Declaration of Abandonment, Abandonment Proceeding No. 030-2023 (NAIA).

## NOTICE AND DECLARATION OF ABANDONMENT

WHEREAS, in a Memorandum received by the Law Division, this Port, Arnaldo R. dela Torre, Jr., Acting Chief, Customs Bonded Warehouse Division (CBWD), this Port, forwarded a Disposition Form approved by the Deputy Collector for Operations recommending the issuance of abandonment proceeding of the attached "Report of Overstaying Goods stored at CBW No. 83 as of 01/08/2023";

WHEREAS, upon evaluation of the records and the submitted List entitled "Report of Overstaying Goods stored at CBW No. 83 as of 01/08/2023", forty-two (42) shipments are reportedly stored and intact at CBW No. 83.

WHEREAS, records further show that said shipments identified the said List arrived in the Port of NAIA on various dates, and remained unclaimed despite service and/or posting of required Notice to Claim and Final Notice to Claim as attested by Christopher Emmanuel U. Avila, CBW Operator and Primodean A. Guerrero, Customs Warehouse Supervisor, Paircargo Warehouse, CBW No. 83 respectively dated 03 August 2023 and 13 August 2023.

WHEREAS, the subject shipments are deemed abandoned pursuant to Section 1129 (b) in relation to Section 407 of the Customs Modernization and Tariff Act, which provides that:

Section 1129 provides: Abandonment, kinds and Effects of. - Imported goods are deemed abandoned under any of the following circumstances:

(b) When the <u>owner, importer, consignee, or interested party</u> <u>after due notice, fails to file the goods declaration</u> within the prescribed period in Section 407 of this Act;

Section 407. Goods Declaration and Period of Filing. —

x x x

Goods declaration must be lodged within fifteen (15) days from the date of discharge of the last package from the vessel or aircraft. (Emphasis and underline supplied.)

WHEREFORE, premises considered, subject shipments listed in the herein attached "Report of Overstaying Goods stored at CBW No 83 as of 01/08/2023" are declared ABANDONED in favor of the government pursuant to Section 1129 (b) in relation to Section 407 of the Customs Modernization and Tariff Act (CMTA), without prejudice to the possible criminal or administrative liability of the importer, or its officers and employees as may be warranted, the same to be turned over to the Auction and Cargo Disposal Division, this Port, for inventory, custody and safekeeping pending the final disposition thereof in the manner provided for by law.

Let copies of this Notice and Declaration of Abandonment be furnished to all parties and offices concerned, and a copy thereof be posted on the Bulletin Board of the Law Division, this Port, for their information and guidance.
