NOTICE AND DECLARATION OF ABANDONMENT

WHEREAS, in a Memorandum received by the Law Division, this Port, Arnaldo R. dela Torre, Jr., Acting Chief, Customs Bonded Warehouse Division, this Port, forwarded a Disposition Form approved by the Deputy Collector for Operations recommending the issuance of abandonment proceeding of the attached "Report of Overstaying Goods stored at CBW No 083, Paircargo Express Cargo Clearance Facility (ECCF) as of 06 October 2023."

WHEREAS, upon evaluation of the records and the submitted "Report of Overstaying Goods stored at CBW No 083, Paircargo Express Cargo Clearance Facility (ECCF) as of 06 October 2023", Three Hundred Thirty-Four (334) shipments are reportedly stored and intact at ECCF Paircargo Facility, CBW No. 83. Records further show that subject shipments arrived in the Port of NAIA on various dates, and remained unclaimed despite service and/or posting of required Notice to Claim and Final Notice to Claim as attested by Gualberto L. Constantino Jr., Broker Manager, RAF International Forwarding Phils. Inc. per Certifications dated 6 October 2023 and 20 October 2023.

WHEREAS, the subject shipments are deemed abandoned pursuant to Section 1129 (b) in relation to Section 407 of the Customs Modernization and Tariff Act, which provides that:

Section 1129. *Abandonment, kinds and Effects of.* - Imported goods are deemed abandoned under any of the following circumstances:

Section 407. *Goods Declaration and Period of Filing.* —

Let copies of this Notice and Declaration of Abandonment be furnished to all parties thru the Paircargo ECCF Warehouse, CBW No. 83, and offices concerned, and a copy thereof be posted on the Bulletin Board of the Law Division, this Port, and electronic posting in the BOC website, thru the Public Information and Assistance Division (PIAD) pursuant to existing Customs laws, rules and regulations.




