## WARRANT OF SEIZURE AND DETENTION

**GREETINGS:** 

WHEREAS, based on derogatory information and documents received by CIIS-POM, the subject vessel was under repair by Chesteel Marine Industrial Corp., located at 7E Rodriguez St., Navotas City;

WHEREAS, a certificate of deletion of ship registration was issued by the Maritime Safety Administration of the People's Republic of China dated 16 June 2021, which makes the subject vessel stateless and unregistered, with no proof of paying duties and taxes;

**WHEREAS,** in a Certification dated 04 April 2023 issued by Atty. Eusebia A. Cadlum-Boco, Regional Director, Regional Office VIII, Maritime Industry Authority (MARINA), Regional Office VIII, the subject vessel is not covered for the issuance of Special Permit to Navigate under the provision of MARINA MC MS No. 2023-01, which covers and/or applies only to all Philippines-registered ships engaged in domestic operation;

WHEREAS, in a Memorandum dated 23 November 2023, IO II Joel C. Pinawin, Field Station Chief, CIIS-POM, recommended the issuance of a Warrant of Seizure and Detention (WSD) against the subject vessel;

**WHEREAS**, probable cause exists to issue a WSD for violation of Section 117, in relation to Section 1113 of the CMTA;

WHEREAS, the vessel is presently docked at Chesteel Marine Industrial Corp., located at 7E Rodriguez St., Navotas City.

**WHEREFORE**, by virtue of the authority vested in me by law, and in compliance with pertinent Customs laws, rules and regulations, <u>you</u>, together with the representative of this office, are hereby ordered to forthwith seize the aforementioned articles and turn them over to the custody of the Auction and Cargo



Disposal Division of this Port, in compliance with Customs Administrative Order (CAO) No. 10-2020 and CAO No. 3-2019, particularly on the matter of making a return of service and the submission of the inventory report or list of the article/s seized is to be strictly observed and **finally**, **you are hereby ordered to return the aforesaid Warrant within twenty-four (24) hours from service, to the Law Division, this Port. Failure to do so, the Warrant shall ipso facto be considered null and void.**

#### DISCUSSIONS:

- 1. Based on derogatory information and document on-hand received by this office that a certain vessel named "KAI DA 899" was under repair by Chesteel Marine Industrial Corp. located at 7E Rodriguez St., Naqvotas 1490 Metro Manila.
- 2. Upon further verification, it was found that the subject vessel has no valid permit from Maritime Industry Authority based on the certification issued by them dated 04 April 2023.
- 3. Furthermore based on the letter from CG Admiral Artemio M. Abu, Commandant, Philippine Coast Guard, it was also noted that the subject shipment was consider as stateless vessel which lacks on proper registration thus has no evidence paying the duties and taxes.
- 4. In addition, a certificate from China stating that the registration of the said vessel was deleted and a Certificate of Deletion of Ship Registration was issued.

## Dear ATTY, TORREON:

This is in connection to the lefter you sent to the Philippine Coast Guard (PCG) with respect to your following request: (a) the full repair and rehabilitation of the distributed supply vessel. "Kai Da 899" preferably in the ship repair facilities in Subic, Pamparga or Batangas; (b) the repatriation of crewmen except to the requested number of personnel to man the vessel, and (c) a Filipino Ship Captain be designed as the interm to man the vessel while in territorial waters of the Philippines.

Please be informed that when the distress Supply Vessel KAI DA 899 requested assistance from the PCG, there was an implied consent on their part to be boarded by PCG personnel in order to inspect the status and welfare of its crews, the seaworthiness of the vessel and to check of the aforesaid vessel is equipped with the necessary legal documents onboard.

Noteworthy to stress, during the conduct of the inspection, the master or the crewcould not provide other legal documents of the vessels and the only document presented to the VSEI learn was a Certificate of Deletion of Ship Registration from the Mantime Safety Administration of the People's Republic of China which makes the vessel a stateless vessel.

For academic discussion, a stateless vessel is one that lacks proper registration, has no flag or has flies two or more flags. Under current international taw regime, "statelessness" is not per se repugnant to the law of nations, however, in order to protect the international regime of the high seas, stateless vessels are generally subject to the jurisdiction of all nations.

Thus, in the jurisdiction of the enforcing State, the stateless costed is empled to all nation legislation.

Furthermore, the allegation that the said documents were all ose due to the big weives that the vessel encountered at the see is suspect and therefore cannot be given prester ment. The crew of the vessel should observe entra ordinary disjence and the documents should always be secured in the safest area of the vessel.

Subsequently, on February 13, 2023, the Administrative Adjudication for the case against Supply Vessel Kai Da 699' was conducted by the PCG at Coast Guard Station Eastern Leyte. After perusal of the circumstances and evidence at hand, a resolution was issued on March 02, 2023 (Encil).

Based on the resolution, the Agency has resolved to permit the repair of the vessel at a reputable shippard nearby, subject to certain conditions. The owner or authorized representative of the vessel must sign an Affidavit of Undertaking, and the Respondent must obtain a special permit from MARINA to riavigate to the shippard at their Own expense, including the cost of a tugboat if needed.

As to the issue concerning the repatriation of crewmen except to the requested number of personnel to man the vessel, this Agency interposes to objection on the said request. Likewise, this Agency recommends to make proper coordination and meeting with the Bureau of Immigration and other government agencies concerned to have a speedy resolution.

Moreover, The PCG allows the Filipino Ship Captain to temporanty operate the vessel white it is in Philippine waters, but can be replaced by the Chinese Ship Captain once the ship is permitted to return to China.

Lastly, please be advised that the Resolution on the EIAR case against the supply vessel "Kai Da 899" can now be enforced within the jurisdiction of the Coast Guard District handling the case, without requiring approval from the Higher Command of the Philippine Coast Guard, unless the respondent has filed an appeal.

Rest assured that this Agency is always guided by what is just under the rule of law.


