NOTICE AND DECLARATION OF ABANDONMENT

WHEREAS, the Chief, Baggage Assistance Division, thru Mr. Norsalem Raymund M. Mama-o, Acting Deputy Collector for Passenger Service, recommended the institution of abandonment proceedings against all overstaying/unclaimed pieces of baggage which reportedly remained unclaimed at the Interline Baggage Room and Inbond Section at the NAIA Terminals 1 and 3;

WHEREAS, based on the same Memorandum, various airlines reportedly submitted to the Baggage Assistance Division, a total of Four Hundred Ten (410) pieces of baggage at the Interline Baggage Room and Twelve (12) pieces of baggage at Inbond Section at the NAIA Terminals 1 and 3, remained unclaimed despite Notices to Claim, the details of which are as follows:

WHEREAS, the corresponding Notices to Claim of the listed pieces of baggage were posted in the Bulletin Boards of the Baggage Assistance Division and Office of the Deputy Collector for Passenger Service at the NAIA International Passenger Terminals 1, 2, and 3 and the Office of the District Collector, NAIA Customhouse to claim their baggage within seven (7) days from posting. Notwithstanding, however, as of this date, the respective passengers of the attached Lists of Overstaying Baggage for the month of May, June, and July 2023 failed and continue to fail to claim, nor manifest any intention to claim the same.

WHEREAS, Section 4.2.4 (b) of Customs Administrative Order (CAO) No. 17-2019 provides:

4.2.4. Failure to Claim the Goods.

(b) Passenger's baggage or mail matter shall be claimed by the passenger or postal consignee within thirty (30)



calendar days from arrival thereof. Otherwise, the shipment shall be deemed abandoned.

The District Collector concerned shall issue a Notice to Claim passenger's baggage or mail matter to the passenger or postal consignee within five (5) calendar days from arrival.

WHEREAS, Section 11.4 of CAO No. 2017 provides: **Section 11. Treatment of In-Bond Baggage.**

XXX

11.4 All In-Bond Baggage, which remain unclaimed after thirty (30) days from arrival shall be subject to abandonment proceedings.

WHEREFORE, premises considered, the above-described pieces of baggage be, as it is are hereby declared **ABANDONED** in favor of the government pursuant to Section 4.2.4 (b) of CAO No. 17-2019 and Section 11.4 of CAO No. 1-2017, the same to be turned over to the Auction and Cargo Disposal Division (ACDD), this Port, for inventory, custody and safekeeping pending the final disposition thereof in the manner provided for by law.

Let copies of this Notice and Declaration of Abandonment be furnished to all parties thru the Baggage Assistance Division, this Port and offices concerned, and a copies thereof be posted on the Bulletin Board of the Law Division, this Port, and electronic posting in the BOC website, thru the Public Information and Assistance Division (PIAD) pursuant to existing Customs laws, rules and regulations.
