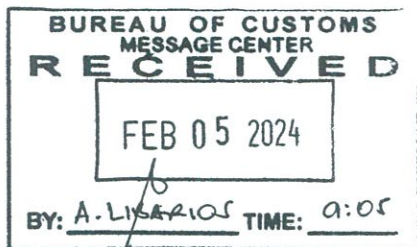

DEPARTMENT PERSONNEL ORDER NO. 131.2024

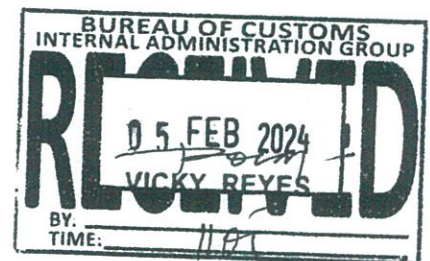
