ADDITIONAL REQUIREMENTS FOR REGULATED SHIPMENTS:

- Pursuant to Section 5.9 of Customs Administrative Order No. 03-2020, persons interested to participate in the bidding of regulated goods must comply or present a Clearance or Registration from the concerned government agency.
- Prior to release of goods, all required Clearances or Certifications, if any, shall be presented and submitted to this Port.

BASIC GUIDELINES:

1. Filing of the complete and duly notarized Registration Form (Port of Cebu Form) and registration in the logbook, shall only be accepted from the date of official posting of the Notice of Public Auction Sale until **01 March 2024 between 08:00 AM up to 5:00 PM**, which shall include but are not limited to the following required documents:
 - Original or Certified True Copy of the latest income Tax and/or business Tax Return duly stamped "RECEIVED" by the Bureau of Internal Revenue, with validated tax payment made on the latest Income Tax Return. (BIR Form 2303 if it is a new corporation)
 - Two (2) Government Identification Cards of the Bidder and the authorized representative of the bidder.
2. If necessary, a Special Power of Attorney / Notarized Partnership Resolution / Board Resolution and Secretary's Certificate authorizing the representative of the Bidder to act for and in behalf of the Bidder and to specifically perform the following acts:
 - to register the Bidder
 - to participate in the Public Auction Sale on **06 March 2024**, in the Port of Cebu
 - to submit the necessary documents
 - to post the necessary bond
 - to sign and execute documents
 - to bid and bind the Bidder
 - to tender payment
 - to receive documents in behalf of the Bidder
3. Any new, additional, supplemental or remedial paper / document shall no longer be accepted after the aforementioned deadline.
4. The Public Auction Sale shall comply with all relevant law, rules and regulations.

- Qualified bidders shall strictly observe social distancing.
 - Only the qualified bidder and one (1) companion shall be allowed inside the designated place for the Public Auction.
 - All participants shall at all times maintain proper and professional decorum.
6. The Auction Committee by a vote of simple majority, may disqualify any bidder or companion from participating or attending in the Public Auction Sale. The disqualified bidder or companion shall be removed from the premises.
7. There shall be a payment of Php 5,000.00 Registration Fee, and legal research fee of Php 50.00 (non-refundable).
8. Posting of a duly receipted bond upon registration shall be made in cash or in manager's check (if amount is above Php 3,500.00) in an amount equivalent to:

Floor Price	Bond
Not over Php 10,000.00	None
Over Php 10,000.00 but not over Php 1,000,000.00	20%
Over Php 1,000,000.00 but over Php 2,500,000.00	15%
Over Php 2,500,000.00 but not over Php 5,000,000.00	10%
Over Php 5,000,000.00	5%

9. At the end of the bidding, the highest bidder shall be required to pay on cash / manager's check equivalent to fifty (50%) of the bid price "ON THE SPOT" upon announcement of the winning bid on top of the bond in cash or manager's check as required in the immediately preceding paragraph. The remaining balance shall be paid on the succeeding business day. Failure to make any of the payments as required shall disqualify the bidder from participating further in the public auction sale and negotiated sale thereof, if applicable. This is without prejudice to the forfeiture of cash bond and other payments made and the imposition of other sanctions as may be warranted.
10. The Public Auction Sale shall be conducted through sealed bids, which shall be submitted and opened in public by the Auction Committee at a time, date and place specified in the Notice of Public Auction Sale.
11. The highest bid shall be declared as the winner except when clustering occurs. Clustering occurs when the difference between the highest and second highest bid is within the ten percent (10%) of the highest bid. In such case, an open bidding shall be conducted among the bidders of the particular sale lot who are present with the highest bid serving as the new floor price. Only bids raised by three percent (3%), more than the new floor price shall be considered and the highest bid in the open bidding shall be declared as the winner. Otherwise, the highest sealed bid shall be declared as the winner.

12. A failed bidding shall be declared by the Auction Committee when any of the following circumstances occurs:
 - When there is only one (1) sealed bid, the same shall not be opened.
 - When there are two (2) sealed bids but there is only one bid higher than the floor price.
 - When there is no bid.
 - When the highest bidder fails to comply with any of the payments required under Section 5.0 of CAO No. 03-2020, said bidder shall be disqualified from participating further in the Public Auction Sale.
13. Clearances or Permits from the regulatory agency shall be required prior to the release of regulated goods, if applicable.
14. Payment with Manager's Check to the Bureau of Customs, District Port of Cebu (BOC, POC) shall bear:
 - a. Pay to: **BOC FAO Bidder Name**
15. When the winning bidder fails to claim the items or lots awarded to him within thirty (30) calendar days from the date of award, upon DUE NOTICE, he shall be deemed to have abandoned the said goods and to have renounced all his rights thereto including forfeiture of all payments made thereon, except upon justifiable reason, as determined by the District Collector, upon recommendation of the Auction Committee.
16. Non-compliance with any of the terms and conditions of the Notice of Public Auction or applicable laws, rules and regulations shall result in the forfeiture of any payments made by the winning bidder without prejudice to the forfeiture of the subject shipments in favor of the government.
17. Finally, the herein terms and conditions of the Notice of Public Auction Sale and all applicable laws, rules and regulations shall be mandatory.
