## CONTRACT FOR THE MAINTENANCE, MANAGED TECHNICAL SUPPORT, AND SOFTWARE AND HARDWARE UPGRADE OF THE CORE RELATIONAL DATABASE MANAGEMENT SYSTEM COMPONENTS OF THE BUREAU OF CUSTOMS

## KNOW ALL MEN BY THESE PRESENTS:

The **BUREAU OF CUSTOMS**, a national agency of the Philippine Government under the Department of Finance, constituted and established under the laws of the Republic of the Philippines with principal office address at Office of the Commissioner Building, Gate 3, South Harbor, Port Area, Manila City, represented herein by its Commissioner, **BIENVENIDO Y. RUBIO** herein referred to as "**Procuring Entity**";

-and-

The RADENTA TECHNOLOGIES INC. with principal office address at Unit 2BC, CBC Corporate Center, 724 Shaw Blvd. Wack Wack, Mandaluyong City represented herein by its Business Development Manager & Authorized Representative, MA. NATHALIE ROSE C. REGALA hereinafter referred to as "Service Provider".

- 3. The Service Provider hereby covenants with the Procuring Entity to provide the Goods and Services and to remedy defects therein in conformity with the provisions of the Contract.
- The Procuring Entity hereby covenants to pay the Service Provider, in consideration of the provision of the Goods and Services and the Contract Price

or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the Contract.
