CUSTOMS MEMORANDUM CIRCULAR No. 17-2024

In line with Customs Memorandum Order No. 14 - 2019, the Exchange Rate duly issued by the Bangko Sentral ng Pilipinas on July 05, 2024 shall be the applicable Rate of Exchange for the week July 06, 2024 to July 12, 2024 for both the regular consumption entries (formal and informal), warehouse entries as well as withdrawal entries for shipments entered under warehousing.
