DECREE OF ABANDONMENT

WHEREAS, On April 25, 2024, this Office received a Notice of Arrival from Randy A. Surtida, of Marine Operations for Eagle Express Lines. On May 4, 2024, MV Danu Bhum arrived at the Port of Zamboanga with Registry No. RCL0010-24.

WHEREAS, fifteen (15) days from the date of discharge, no corresponding goods declaration filed by the consignee, JANDR Agricultural Products Trading on their shipment with Bill of Lading (BL) and container number SGNCB2401331 and SEGU6593350, respectively. The shipment declared was a (5 kg) woven bag with side printing, intended for rice packaging.

WHEREAS, on May 16, 2024, an Urgent Notice to File Goods Declaration was posted at the bulletin board of BOC-Port of Zamboanga.

WHEREAS, on May 22, 2024, Ms. Kayzel Chua, Acting Chief, Cargo Container Unit, instructed Mr. Erwin G. Fernandez, to confirm if the subject shipment is still intact.

WHEREAS, in a Memorandum dated May 23, 2024, Mr. Erwin G. Fernandez, Wharfinger, certified that the subject shipment remains intact inside the container stored at PPA Container Yard.

WHEREAS, Section 1129 (b) of RA 10863 otherwise known as the Customs Modernization and Tariff Act provides, to wit:

Section 1129. Abandonment, Kinds and Effects of. *Imported goods are deemed abandoned under any of the following circumstances:*

(b) When the owner, importer, consignee, or interested party after due notice, fails to file the goods declaration within the prescribed period in Section 407 of this Act: Provided, That the term goods declaration shall include provisional or incomplete goods declaration deemed valid by the Bureau as provided in Section 403 of this Act. For this purpose, it is the duty of the District Collector to post a list of all packages discharged and their consignees, whether electronically or physically in the District Office, or send a notice to the consignee within five (5) days from the date of discharge;

(c) Having filed such goods declaration, the owner, importer, consignee or interested party after due notice, fails to pay the assessed duties, taxes and other charges thereon, or, if the regulated goods failed to comply with Section 117 of this Act, within fifteen (15) days from the date of final assessment: Provided, That if such regulated goods are subject of an alert order and the assessed duties, taxes and other charges thereof are not paid within fifteen (15) days from notification by the Bureau of the resolution of the alert order, the same shall also be deemed abandoned; or

(d) Having paid the assessed duties, taxes and other charges, the owner, importer or consignee or interested party after due notice, fails to claim the goods within thirty (30) days from payment. For this purpose, the arrastre or warehouse operator shall report the unclaimed goods to the District Collector for disposition pursuant to the provisions of this Act;

XXXX

Section 407. Goods Declaration and Period of Filing. – xxx Goods declaration must be lodged within fifteen (15) days from the date of discharge of the last package from the vessel or aircraft. The period to file the goods declaration may, upon request, be extended on valid grounds for another fifteen (15) days: Provided, That the request is made before the expiration of the original period within which to file the goods declaration. Provided, however, That the period of the lodgement of the goods declaration may be adjusted by the Commissioner.

WHEREAS, the shipment identified below is deemed abandoned pursuant to Section 1129 (b), (c), and (d) and 407 of the CMTA, to wit:
