NOTICE AND DECLARATION OF ABANDONMENT

WHEREAS, on 26 July 2024, the Law Division, this Port, received a Memorandum dated 04 July 2024 from IOV Richard S. Rebong, DPA, Chief, Baggage Assistance Division, thru Norsalem Raymond M. Mama-O, Acting Deputy Collector for Passenger Service, recommending the institution of abandonment proceedings against the overstaying/unclaimed baggage at the Interline and In-bond Baggage Room, Port of NAIA;

WHEREAS, hereunder is a list of overstaying/unclaimed baggage which remained in custody at the Interline and In-Bond Baggage Room at Terminal 1 & 3, Port of NAIA, despite the posting of a Notice to Claim, the details of which are as follows;

WHEREAS, Section 4.2.4 (b) of Customs Administrative Order (CAO) No. 17-2019 provides:

4.2.4. Failure to Claim the Goods.

(b) Passenger's baggage or mail matter shall be claimed by the passenger or postal consignee within thirty (30) calendar days from arrival thereof. Otherwise, the shipment shall be deemed abandoned.

The District Collector concerned shall issue a Notice to Claim passenger's baggage or mail matter to the passenger or postal consignee within five (5) calendar days from arrival.

WHEREAS, Section 10.4 of Customs Administrative Order (CAO) No. 1-2017 provides: **Section 10. Treatment of Interline Baggage.**

xxx

10.4. All Interline Baggage, which remain unclaimed after thirty (30) days from arrival shall be subject to abandonment proceedings.



WHEREAS, Section 11.4 of CAO No. 1-2017 provides: **Section 11. Treatment of In-Bond Baggage.**

XXX

11.4 All In-Bond Baggage, which remain unclaimed after thirty (30) days from arrival shall be subject to abandonment proceedings.

WHEREAS, records show that from the time the subject articles were inbonded, the reglementary period for claiming such items had already lapsed, as expressly mentioned in the above-captioned provision.

WHEREAS, consignees were directed to claim their respective baggage/pieces of baggage within seven (7) days from the posting of the Notice to Claim as attested by Maria Sarah H. Asilo, Warehouseman IV, In-Bond Section & Interline Baggage Room, Terminal 1 & 3, Annaliza L. Reyes, Warehouseman, In-Bond Section & Interline Baggage Room, Terminal 1 & 3, Jonathan T. Mesa, Acting Warehouseman and IOV Richard S. Rebong, DPA, Chief, Baggage Assistance Division.

WHEREFORE, premises considered, the above-described pieces of baggage be, as it is are hereby declared **ABANDONED** in favor of the government pursuant to Section 4.2.4 (b) of CAO No. 17-2019 and Section 11.4 of CAO No. 1-2017, the same to be turned over to the Auction and Cargo Disposal Division (ACDD), this Port, for inventory, custody and safekeeping pending the final disposition thereof in the manner provided for by law.

Let copies of this Notice and Declaration of Abandonment be furnished to all parties thru the Baggage Assistance Division, this Port and offices concerned, and a copies thereof be posted on the Bulletin Board of the Law Division, this Port, Office of the Baggage Assistance Division and electronic posting in the BOC website, thru the Public Information and Assistance Division (PIAD) pursuant to existing Customs laws, rules and regulations.
