WHEREAS, Section 4.2.4 (b) of Customs Administrative Order (CAO) No. 17-2019 provides:

# 4.2.4. Failure to Claim the Goods.

(b) Passenger's baggage or mail matter shall be claimed by the passenger or postal consignee within thirty (30) calendar days from arrival thereof. Otherwise, the shipment shall be deemed abandoned.

The District Collector concerned shall issue a Notice to Claim passenger's baggage or mail matter to the passenger or postal consignee within five (5) calendar days from arrival.

WHEREAS, Section 10.4 of Customs Administrative Order (CAO) No. 1-2017 provides: Section'10. <u>Treatment of Interline Baggage</u>.

XXX

10.4. All Interline Baggage, which remain unclaimed after thirty (30) days from arrival shall be subject to abandonment proceedings.

WHEREAS, Section 11.4 of CAO No. 1-2017 provides: Section 11. Treatment of In-Bond Baggage.

XXX

### 11.4 <u>All In-Bond Baggage, which remain unclaimed after</u> thirty (30) days from arrival shall be subject to abandonment proceedings.

WHEREAS, records show that from the time the subject articles were inbonded, the reglementary period for claiming such items had already lapsed, as expressly mentioned in the above-captioned provisions.

WHEREAS, consignees were directed to claim their respective baggage/pieces of baggage within seven (7) days from the posting of the Notice to Claim as attested by Maria Sarah H. Asilo, Warehouseman IV, In-Bond Section & Interline Baggage Room, Terminal 1 & 3, Annaliza L. Reyes, Warehouseman, In-Bond Section & Interline Baggage Room, Terminal 1 & 3, Jonathan T. Mesa, Acting Warehouseman and IOV Richard S. Rebong, DPA, Chief, Baggage Assistance Division.

WHEREAS, in a Certification dated 29 July 2024, consignees identified in the attached List of Unclaimed Baggage were duly informed of the arrival of their respective shipments. However, the respective consignees failed and continue to fail to claim, nor manifest any intention to claim the same.

WHEREFORE, premises considered, the above-described pieces of baggage be, as it is are hereby declared ABANDONED in favor of the government pursuant to Section 4.2.4 (b) of CAO No. 17-2019 and Section 11.4 of CAO No. 1-2017, the same to be turned over to the Auction and Cargo Disposal Division (ACDD), this Port, for inventory, custody and safekeeping pending the final disposition thereof in the manner provided for by law.
