CUSTOMS MEMORANDUM CIRCULAR No. 167-2024

To: **All Collectors of Customs**

Importers, Customs Brokers, Brokers' Representatives and All Others Concerned

In line with Customs Memorandum Order No. 14 - 2019, the Exchange Rate duly issued by the Bangko Sentral ng Pilipinas on 11 October 2024 shall be the applicable Rate of Exchange for the week 12 October 2024 to 18 October 2024 for both the regular consumption entries (formal and informal), warehouse entries as well as withdrawal entries for shipments entered under warehousing.
