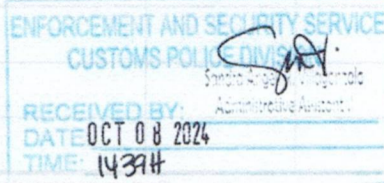

WARRANT OF SEIZURE AND DETENTION

To: ESS-CPD

WHEREAS, on 28 June 2024, Malapatan Municipal Police Station received an information thru phone call on the alleged selling of smuggled cigarettes at Purok Masbong 2, Brgy. Poblacion Malapatan, Sarangani Province. In response, Malapatan MPS, together with 1st SPMFC, SPPO PIU and STTA-RID 12, conducted an operation on the reported area which resulted to the seizure of the following articles, to wit:

WHEREAS, on 03 July 2024, the above-seized articles were turned over by Police Major Lloyd Levin D. Caigas, through PMSg Julius C. Ancao, from Malapatan Municipal Police Station, Sarangani Province, and received by SAI Rogel E. Julio, Sector Commander, ESS-CPD, Sub-Port of General Santos, for safekeeping and for purposes of proper disposition;

WHEREAS, 03 July 2024, Customs Examiner Jovannie D. Prado, submitted a report, relative to the conduct of physical examination of the seized items. Customs Examiner Prado issued a certification that the seized goods were considered as smuggled and recommended for the issuance of a Warrant of Seizure and Detention in violation of Section 117, Section 1113 and Section 400 of R.A. No. 10863 otherwise known as the "Customs Modernization and Tariff Act (CMTA)";

WHEREAS, on 04 September 2024, ESS District Commander SP/LT. Mangurun C. Batuampar, Jr., and CIIS Chief IO-II Felix A. Espino III, also recommended for the issuance of Warrant of Seizure and Detention; and

WHEREFORE, by virtue of the authority vested by law in this Office, you are hereby ordered to forthwith SEIZE the aforementioned articles and take into physical possession and, custody thereof. Compliance with Customs Administrative Order No.10-2020, particularly, in the manner of making a return of service is likewise prescribed and the submission of inventory Report on the list of the seized cargo is to be strictly observed.
