WARRANT OF SEIZURE AND DETENTION

To: The District Commander ESS-CPD, Port of Davao

WHEREAS, on 29 October 2024, a Mission Order No. EGMO-219-2024 and Sailing Order No. WPD-092-2024 were issued by SP/Chief Isabelo A. Tibayan III, Acting Director, ESS and approved by Atty. Teddy Sandy S. Raval, Deputy Commissioner, Enforcement Group to CQM Timothy Jasper B. Nicolas, CSM Ralph Ashley F. Marasigan, MEI Justine John O. Jose, and SAI Raymund L. Salazar, to conduct regular Maritime Patrol along the vicinity waters of Regions XI and XII;

WHEREAS, on 09 November 2024, the above-named personnel conducted a Maritime Patrol at the vicinity waters of Davao Gulf, which resulted to the seizure of the following goods, to wit:

WHEREAS, on 10 November 2024, the above seized cigarettes were transported to the Bureau of Customs' Security Warehouse in Panacan, Davao City and the motorized banca was docked and secured at Sta. Ana Wharf, for safekeeping and for purposes of proper disposition;

WHEREAS, on 12 November 2024, SP/Capt. Mangurun C. Batuampar, Jr., ESS District Commander and CQM Timothy Jasper B. Nicolas, Station Chief, ESS-WPD, submitted an after operation report on the apprehension of the above described goods and recommended for the issuance of Warrant of Seizure and Detention;



WHEREAS, on 13 November 2024, Customs Examiner Amer-Hassan G. Mangoyag, Jr., submitted a report relative to the conduct of physical examination of the seized items in the presence of ESS personnel, SAI Dariz Jo S. Pascual and SAI Raymond L. Salazar. Customs Examiner Mangoyag recommended for the issuance of a Warrant of Seizure and Detention in violation of Section 117, Section 1113 and Section 400 of R.A. No. 10863 otherwise known as the "Customs Modernization and Tariff Act (CMTA)". Such recommendation was concurred to by Pangandaman C. Casan, Acting Chief, Assessment Division and Atty. Vicente V. Yutangco, Jr., Deputy Collector for Assessment;

WHEREFORE, by virtue of the authority vested by law in this Office, you are hereby ordered to forthwith SEIZE the aforementioned articles and take into physical possession and, custody thereof. Compliance with Customs Administrative Order No.10-2020, particularly, in the manner of making a return of service is likewise prescribed and the submission of inventory Report on the list of the seized cargo is to be strictly observed.
