## AMENDMENTS TO THE NOTICE OF NEGOTIATED SALE 18 DECEMBER 2024

Pursuant to Section 1149 of Republic Act (RA) No. 10863, otherwise known as the Customs Modernization and Tariff Act of 2016, and Customs Administrative Order (CAO) No. 03-2020 and CAO No. 10-2007, as amended, Customs Memorandum Order No. 26-2020, and other relevant issuances, as amended, a Notice of Negotiated Sale to be held on 18 December 2024 was published in The Manila Times and the Bureau of Customs (BOC) Official Website on 07 December 2024 which includes Twenty Three (23) Sale Lots, i.e., 111x20' Container Vans of Sugar Shipments, indorsed by the Port of Subic.

However, in a letter dated 12 December 2024 from Mr. Pablo Luis S. Azcona, Administrator and Chief Executive Officer, Sugar Regulatory Administration, Department of Agriculture, in order to ensure public safety, it was recommended to the Bureau of Customs the condemnation of these sugar shipments located at the Port of Subic.
