





This refers to the herein attached **ABANDONMENT PROCEEDING NO. 040-2024 (NAIA)**: Seventy-Seven (77) overstaying cargoes/parcels which remained unclaimed at **DHL EXPRESS FACILITY, CBW No. 185**.

As the consignees/claimants of the aforementioned overstaying/unclaimed shipments failed to claim their respective shipments despite due notice, this Office deems it practicable to cause the electronic posting in the Bureau's official website a copy of the issued Notice and Declaration of Abandonment, Abandonment Proceeding No. 040-2024 (NAIA).

In view of the foregoing, it is hereby respectfully requested that a copy of the Notice and Declaration of Abandonment, docketed as Abandonment Proceeding No. 040-2024 (NAIA), together with its attachments, be electronically posted with the BOC website for fifteen (15) days. NOTICE AND DECLARATION OF ABANDONMENT

WHEREAS, in a Disposition Form dated 28 October 2023 of Arnaldo R. dela Torre, Jr., Acting Chief, Customs Bonded Warehouse Division, this Port, and concurred by Wilnora L. Cawile, Deputy Collector for Operations, recommended for the issuance of abandonment proceeding of the attached List of a total of Seventy Seven cargoes/parcels currently stored at DHL Express Warehouse Facility.

WHEREAS, upon evaluation of the records and the submitted List, the subject shipments arrived at the Ninoy Aquino International Airport on various dates, and remained unclaimed despite service and/or posting of required Notice to Claim and Final Notice to Claim as attested by Myrtle Grace Valeriano, OIC Customs Clearance Manager and Renato Guiang, Warehouse Supervisor – DHL CBW 185, in Certifications respectively dated 30 August 2024 and 15 September 2024.

WHEREAS, the subject cargoes/parcels are deemed abandoned pursuant to Section 1129 (b) in relation to Section 407 of the Customs Modernization and Tariff Act, which provides that:

Section 1129. *Abandonment, kinds and Effects of.* - Imported goods are deemed abandoned under any of the following circumstances:

X X X

(b) When the **owner, importer, consignee, or interested party after due notice, fails to file the goods declaration** within the prescribed period in Section 407 of this Act;

Section 407. *Goods Declaration and Period of Filing.* —

X X X

Goods declaration must be lodged within fifteen (15) days from the date of discharge of the last package from the vessel or aircraft. (Emphasis and underline supplied.)



WHEREFORE, premises considered, the goods listed in the attached “**Report of Overstaying Goods stored at CBW No. 185, DHL Express Phils.**”, are hereby declared **ABANDONED** in favor of the government pursuant to Section 1129 in relation to Section 407 of the Customs Modernization and Tariff Act (CMTA), *without prejudice to the possible criminal or administrative liability of the importer, or its officers and employees as may be warranted*, the same to be turned over to the Auction and Cargo Disposal Division, this Port, for inventory, custody and safekeeping pending the final disposition thereof in the manner provided for by law and subject further to the strict compliance with existing customs laws, rules, and regulations.

Let copies of this Notice and Declaration of Abandonment be furnished to all parties thru the DHL Express Warehouse, CBW No. 185 and offices concerned, a copy thereof be posted on the Bulletin Board of the Law Division, this Port, and electronic posting in the BOC website, through the Public Information and Assistance Division (PIAD) pursuant to existing Customs laws, rules and regulations.
