
DEPARTMENT ORDER NO. 001.2025

In the interest of the service, the travel authorizations (TAs) of all officials, rank-and-file employees, and personnel under the Department of Finance (DOF), including its Operating Bureaus (OBs), Attached Agencies (AAs), and supervised Government Financial Institutions (GFIs)/Corporations shall be approved by the following DOF officials, effective immediately:

1. **Secretary of Finance:** Official and personal foreign travels of: (i) All DOF Undersecretaries and Assistant Secretaries; (ii) All Heads, including officials with the rank equivalent to Assistant Secretary and above, of the DOF's OBs, AAs, and supervised GFIs/Corporations; and (iii) All officials of the Bureau of Customs (BOC) and the Bureau of Internal Revenue (BIR);
2. **Undersecretary and Chief of Staff of the Office of the Secretary:** Official and personal foreign travels of all local treasurers and assistant local treasurers of provinces, cities, and municipalities;
3. **Undersecretary of the Revenue Operations Group:** Official and personal foreign travels of all rank-and-file employees and personnel of the BOC and the BIR; and
4. **Undersecretary of the Policy Development and Management Services Group:** (i) Official and personal foreign travels of all DOF Directors, rank-and-file employees, and personnel; and (ii) Official foreign travels of all other officials with the rank equivalent to Director and below of OBs, AAs, and supervised GFIs/Corporations.

This Department Order (DO) amends Item 4.1 of DO No. 061.2024 and all other issuances of this Department that are inconsistent herewith are hereby deemed amended or modified accordingly. All other provisions of DO No. 061.2024 not affected by this DO shall remain effective.

All concerned shall be guided accordingly.
