**WARRANT OF SEIZURE AND DETENTION**

To: The District Commander  
ESS-CPD, Port of Davao

WHEREAS, on 06 October 2024, Philippine Navy, Littoral Combat Force, BRP Herminigildo Yurong (PG 906) conducted an Internal Security Operations (ISO) and Maritime Patrol (MARPAT) within the coastal waters of Sarangani. They were able to detect through radar contact a motorized banca and upon verification and inspection, smuggled cigarettes were on board, which resulted to its seizure, to wit:

WHEREAS, on 08 October 2024, the above-seized articles were turned-over by ENS Dawson S. Adaci, PN, from the Philippine Navy to the Bureau of Customs, Port of Davao and received by SA-I Orlando Jose C. Orlino, ESS-CPD, for safekeeping and for purposes of proper disposition;

WHEREAS, on 04 December 2024, Customs Examiner Gil D. Generalao, Jr., submitted a report relative to the conduct of physical examination of the seized items in the presence of IO-I Shaif Macmod C. Guro and SA-I Raymond L. Salazar. Customs Examiner Generalao recommended for the issuance of a Warrant of Seizure and Detention in violation of Section 117, Section 1113 and Section 400 of R.A. No. 10863 otherwise known as the "Customs Modernization and Tariff Act (CMTA)";

WHEREAS, on 09 December 2024, ESS District Commander SP/Capt. Mangurun C. Batuampar, Jr., and CIIS Chief IO-II Felix A. Espino III, also recommended for the issuance of Warrant of Seizure and Detention; and

WHEREFORE, by virtue of the authority vested by law in this Office, you are hereby ordered to forthwith SEIZE the aforementioned articles and take into physical possession and, custody thereof. Compliance with Customs Administrative Order No.10-2020, particularly, in the manner of making a return of service is likewise prescribed and the submission of inventory Report on the list of the seized cargo is to be strictly observed.
