**Terms and Conditions of Public Auction:**

1. Filing of Bidder's Registration Form (with name, address, and TIN), together with the certified true copy of Income and/or Business Tax Returns duly stamped and received by the Bureau of Internal Revenue (BIR) with a validated tax payment made thereon, at least two (2) days before the day of the auction.
2. Registration on the logbook of registered bidders indicating the name, address and TIN to be made with the ACDD Chief, a day before the actual bidding until exactly an hour immediately preceding the time of actual bidding; thereafter, registration is closed.
3. Payment of non-refundable PHP 5,050.00 Registration Fee.
4. Posting of duly receipted bond in cash or manager's check in the amount equivalent as stated in CAO 04-2016 (please refer to the table below for the specific amount of bond). The bond shall be refunded to the losing bidder after the auction.

5. Payment with Cashier's/Manager's Check / Cash to the BOC / Port of Clark shall bear the following:
  - a) Pay to the Order of Land Bank of the Philippines – BOC E.O. IFO BOC FAO;
  - b) For the Credit of the Bureau of Customs;
  - c) For the Account of: \_\_\_\_\_; Bidder
6. Failure to submit and sign any documentary requirements shall automatically disqualify the registered bidder from participating further in the public auction.
7. The Public Auction shall utilize a sealed bid system. The sealed bid shall be tendered and opened in public by the Auction and Cargo Disposal Committee (ACDC) members with the presence of the Commission on Audit (COA) representative. The highest bid shall be declared as the winner, except when clustering occurs.



8. At the end of each bidding, the bond posted by the winning bidder shall automatically be part of the bid price. The winning bidder shall pay the bid price less the bond posted within twenty-four (24) hours after the public auction. Failure to pay the remaining balance within the prescribed period shall cause the forfeiture of the bond without prejudice to any sanction that the ACDC may impose.
9. In case such payment has not been made, the subject good/s shall be re-offered three (3) working days for non-perishable and the next working day for perishable goods, unless the Commissioner provides a different period and subject further to compliance with the publication requirements under CAO 03-2020.
10. A failed bidding shall be declared by the ACDC when any of the following circumstances occurs:
  - a) When there is no bid; and
  - b) When the highest bidder fails to comply with any of the payments required under Section 5.10 of CAO 03-2020, said bidder shall be disqualified from participating further in the auction sale and, when applicable, the negotiated sale thereof without prejudice to the forfeiture of the minimum deposit and any payment made and imposition of other sanctions as may be warranted.
11. When the winning bidder fails to claim the items or lot awarded to him within thirty (30) calendar days from the date of award, upon due notice, he shall deem to have abandoned said goods and to have renounced all his rights to it, including forfeiture of all payments made thereon, except upon justifiable reasons, as determined by the District Collector, upon recommendation of the Committee.
12. Representatives from ACDD, ESS, OCOM, CIIS, ODC and COA shall be invited to witness the release.
