4 DESCRIPTION OF GOOD

"NOBIVAC® INTRA-TRAC® ORAL Bb"

Based on the Certificate of Product Registration from the Food and Drug Administration (FDA), product brochure, analytical documentation, product labels, and photographs of the product and packaging submitted, subject article is a freeze-dried avirulent live culture veterinary vaccine with sterile purified water as a diluent. The vaccine is composed of an active substance (*Bordetella bronchiseptica*, strain B-C2), stabilizers (hydrolyzed gelatin, N-Z amine AS, sorbitol-d, sodium phosphate, and purified water), and excipient (phosphate buffer). Packed in boxes containing 25 sets of freeze-dried, single dose vaccine and sterile diluent contained separately in type 1 glass vials, the vaccine is to be rehydrated with 1-mL sterile diluent before administering orally into the buccal cavity of dogs, for the prevention of canine infectious tracheobronchitis caused by *Bordetella bronchiseptica* (Bb) 1.

5 REASONS FOR CLASSIFICATION

Heading 30.02 of the ASEAN Harmonised Tariff Nomenclature (AHTN) 2022 covers, among others, vaccines, toxins, cultures of micro-organisms (excluding yeasts) and similar products. The pertinent Harmonized System (HS) Explanatory Notes (EN) state that the most typical vaccines are prophylactic preparations of microbial origin containing either viruses or bacteria suspended in saline solutions, oil (lipovaccines) or other media. These preparations have usually been treated to reduce their toxicity without destroying their immunizing properties.

In view thereof, subject article is classified under AHTN 2022 subheading 3002.42.00, with a Most Favoured Nation (MFN) rate of duty of 3% ad valorem.

This ruling shall be valid for five years from the date of issuance and shall continue to apply unless the law, facts, or circumstances supporting this ruling have changed.

4 DESCRIPTION OF GOOD

"INNOVAX® ND-ILT"

Based on the Certificate of Product Registration from the Food and Drug Administration (FDA), brochure, product insert, product labels, and chemical, pharmaceutical and biological/microbiological information submitted, subject article is a frozen, dual-construct vaccine containing cell-associated live recombinant turkey herpesvirus (strain HVT/NDV/ILT) with the F gene from Newcastle disease virus and with genes from laryngotracheitis virus, and excipients. It is indicated for the active immunization of 18-day-old chicken embryos or one-day-old chicks against Marek's disease (MD), Newcastle disease (ND), and infectious laryngotracheitis (ILT). Packed in Type I glass ampoules containing 2,000 doses (supplied with a diluent in a separate container), subject article is administered as a single dose of 0.05 mL or 0.1 mL per 18-day-old chicken embryo, via *in ovo* injection; or 0.2 mL per one-day-old chick, via subcutaneous injection.

5 REASONS FOR CLASSIFICATION

Heading 30.02 of the ASEAN Harmonised Tariff Nomenclature (AHTN) 2022 covers, among others, vaccines, toxins, cultures of micro-organisms (excluding yeasts) and similar products. The pertinent Harmonized System (HS) Explanatory Notes (EN) state that the most typical vaccines are prophylactic preparations of microbial origin containing either viruses or bacteria suspended in saline solutions, oil (lipovaccines) or other media. These preparations have usually been treated to reduce their toxicity without destroying their immunizing properties. Other vaccines include recombinant vaccines, peptide vaccines and carbohydrate vaccines. These vaccines generally contain an antigen, a recognised part of an antigen or a gene coding for a recognised part of an antigen (peptides, recombinants or conjugates of protein and others). The "recognised part of an antigen" is the part of an antigen which triggers the immunological response in the organism. Many of these vaccines target a specific virus or bacterium. These vaccines are used for prophylactic or therapeutic purposes.

In view thereof, subject article is classified under AHTN 2022 subheading 3002.42.00, with a Most Favoured Nation (MFN) rate of duty of 3% ad valorem.

This ruling shall be valid for five years from the date of issuance and shall continue to apply unless the law, facts, or circumstances supporting this ruling have changed.

4 DESCRIPTION OF GOOD

"NISSAN NP500"

Based on the technical specifications and photograph of the product submitted, subject article is a completely built-up (CBU), four-wheel drive, mid-size pick-up truck. It is a plug-in, hybrid electric vehicle (PHEV) that uses battery as a main source of power and is capable of using a gasoline engine and an electric motor as the means of propulsion. Subject article has the following specifications:

5 REASONS FOR CLASSIFICATION

Heading 87.04 of the ASEAN Harmonised Tariff Nomenclature (AHTN) 2022 covers motor vehicles for the transport of goods. The pertinent Harmonized System (HS) Explanatory Notes (EN) state that the classification of certain motor vehicles in this heading is determined by certain features which indicate that the vehicles are designed for the transport of goods rather than for the transport of persons (heading 87.03). Included in this category of motor vehicles are those commonly known as "multipurpose" vehicles (e.g., van-type vehicles, pick-up type vehicles and certain sports utility vehicles). The following features are indicative of the design characteristics generally applicable to the vehicles which fall in this heading, among others, presence of a separate cabin for the driver and passengers and a separate open platform with side panels and a drop-down tailgate (pick-up vehicles).

In view thereof, subject article is classified under AHTN 2022 subheading 8704.51.26, with a Most Favoured Nation (MFN) rate of duty of zero; ASEAN-China Free Trade Area (ACFTA) rate of duty of 5% ad valorem, subject to submission of Certificate of Origin (CO) Form "E"; and Regional Comprehensive Economic Partnership (RCEP) Agreement rate of duty of 30% ad valorem from 01 January to 31 March 2025 and 28% ad valorem by 01 April 2025 to 31 March 2030, subject to submission of CO Form "RCEP" or Declaration of Origin (DO) issued by an Approved Exporter.

This ruling shall be valid for five years from the date of issuance and shall continue to apply unless the law, facts, or circumstances supporting this ruling have changed.
